Narrative:

On August 1, 2018, at approximately 0927 hours, Thousand Oaks Police Department patrol deputies responded to the 600 block of Calle Mandarinas, for a burglary in progress call. The victim reported that two Hispanic males broke into her residence while she was home and stole items from the residence. Once the homeowner confronted the suspects they fled in a grey Infinity vehicle. Patrol deputies arrived and searched the area. During the search, Sheriff's Dispatch received another call for a burglary in progress in the 80 block of West Sidlee Street, which is approximately two miles from the Calle Mandarinas location. Additional patrol resources responded and searched the area.

During the search, a Moorpark Police Motor Unit observed a vehicle matching the suspect vehicle driving eastbound on State Route 118. The Moorpark Police Motor unit followed the vehicle until additional police units arrived to assist. The vehicle pulled into the Del Taco restaurant drive through, located at 1098 Enchanted Way in Simi Valley. The three occupants fled from the vehicle and a foot pursuit ensued. With the assistance of Simi Valley Police Department, Ventura County Sheriff's Office K9, and the Ventura County Sheriff's Office Air Unit, all three suspects were taken into custody.

A search of their vehicle revealed stolen property from at least three different residences located in the City of Thousand Oaks. Joseph Mancha, Armando Tellez, and Hope Delaolla were identified as documented gang members from the Bakersfield area. Mancha, Tellez, and Delaolla were arrested for violating Penal Code section 182(a)(1) ' Conspiracy, PC 459 ' Burglary, and PC 186.22(a) ' Street Terrorism.

Thousand Oaks Police Department Detectives are conducting a follow up investigation to

identify the owner of the stolen property found in the vehicle.

Narrative:

A Simi Valley woman was arrested for deliberately setting a fire that burned a hillside in the unincorporated area of Simi Valley.

At about 8:40 a.m. on August 1, 2018, the Ventura County Fire Department received a call of a brush fire in the 4100 block of Tapo Canyon Road. Firefighters arrived within minutes and were able to quickly contain the fire before it grew out of control. In the end, the fire burned almost 10 acres of hillside before it was extinguished.

While on scene, firefighters learned that a citizen had detained a female who was possibly responsible for starting the fire. Patrol deputies from the Ventura County Sheriff's Office, along with investigators from the Fire Department's Arson Unit and the Sheriff's Bomb/Arson Unit, responded to conduct additional investigation. The investigators determined that (S) Alexandra Gindlesberger had deliberately started the fire along the roadside. The fire then spread along the neighboring hillside.

Gindlesberger was arrested for one felony count of arson and one misdemeanor count of possession of drug paraphernalia. She was booked into the Pre-Trial Detention Facility on \$50,000.00 bail and she is scheduled to appear in Ventura County Superior Court on August 3, 2018.

The Ventura County Sheriff's Office and the Ventura County Fire Department would like to remind the public that fire season is still in full effect. Small fires can grow rather quickly and we encourage the public to have an evacuation plan in place.

Narrative:

On 8/2/2018, Detectives with the Ventura County Sheriff's East County Street Team detained a Ventura resident, Dustin Kirn, age 29, regarding an investigation into sales of illegal steroids. Kirn was stopped by a patrol deputy in the area of Spinnaker and Navigator drives. During the search of Kirn's vehicle, detectives located two loaded handguns.

Detectives from the Sheriff's East County Street Team, Pharmaceutical Unit, and Camarillo Police Special Enforcement Detail served search warrants at Kirn's business located on the 2000 block of Palma Drive in Ventura and residence located on the 10000 block of Orange Circle in Ventura.

At the business, detectives seized a significant amount of illegal steroids, a loaded handgun, currency and evidence related to the sales of the illegal steroids. At the residence, detectives seized additional steroids, cash, handguns, and rifles.

At the conclusion, detectives seized over 100 vials and 1,600 pills of illegal steroids, a total of five handguns, a shotgun, assault style rifle, ammunition, and numerous high capacity rifle magazines. One of the magazines was a double drum magazine with a 100 round capacity. Detectives also seized a large sum of cash believed to be proceeds from the sales of illegal steroids.

Kirn was arrested for possession for sale of a controlled substance. Additional charges are pending. Kirn was booked into the Ventura County Main Jail and his bail was set at \$50,0000. Kirn posted his bail and is scheduled to appear in court on 8/16/2018, at 0815 hours.

Narrative:

A Ventura resident was stabbed in Saticoy during what is believed to be a gang-related incident.

On Tuesday, August 7, 2018, deputies were summoned to the 1200 block of Los Angeles Avenue in the unincorporated community of Saticoy, in reference to a stabbing. Headquarters Patrol deputies, as well as investigators from the Sheriff's Gang Unit and Major Crimes Bureau, responded to the incident. Preliminary investigation indicates that three Hispanic male suspects approached an 18-year old victim and the victim's 17-year old friend in the area of Los Angeles Avenue and Azahar Street. One of the suspects made threatening statements and remarks consistent with gang ideology. This same suspect then brandished a knife and continued to verbally threaten the victims.

Upon seeing the suspect with the knife, both victims attempted to run away and they were immediately chased by all three suspects. The 17-year old victim managed to escape assault/injury and fled the scene unharmed. Meanwhile, the three suspects caught up with the 18-year old victim and attacked him in the area of Los Angeles Avenue and Violeta Street. The victim sustained stab wounds during the assault and was later treated at Ventura County Medical Center. The victim's wounds were determined to be non-life threatening and the victim was discharged from the hospital later that evening.

During the investigation, one juvenile suspect who resides in Saticoy was arrested for weapon and drug violations and later lodged at the Juvenile Justice Center. Investigators are still trying to determine if this suspect played a role in the attack.

Narrative:

On 7/24/18, a deputy observed a motorcycle traveling at a high rate of speed. The deputy attempted to initiate a traffic stop and the motorcyclist failed to yield, committing several traffic violations as he attempted to flee. The motorcyclist was later identified as Morgan Sterling.

While fleeing from the deputy, Sterling showed no regard for his safety, pedestrians, or other motor vehicles on the roadway. His actions were so egregious that his failure to yield rose to the level of felony evading, a violation of 2800.2(a) CVC. During the pursuit, Sterling made a sudden illegal U-turn in front of the deputy's vehicle which caused a collision that ending the pursuit.

At the conclusion of the pursuit Sterling was transported to the hospital for minor injuries. The City of Camarillo's Traffic Unit responded and conducted the traffic accident portion of this investigation. In addition to these investigations, a California Driver's License check was conducted and determined the Sterling did not have a Class M1 License issued to him at the time of this incident.

On 08/08/2018, Sterling came to the station with a family member, at the request of detectives, and was arrested for felony evading and reckless driving. He was booked into custody at the Pre-Trial Detention Facility, his bail is set at \$55,000.00 he is scheduled to appear in court on 08/10/2018.

Narrative:

On September 6, 2015, patrol deputies responded to a residence in the 3000 block of Cajon Circle in the Unincorporated area of Camarillo regarding a robbery that had just occurred. Deputies determined two suspects woke up the victim and directed the victim to open his safe for them. The suspects stole a large amount of US currency, jewelry and documents. The suspects then restrained the victim before fleeing the victim's residence.

Detectives with the East County Investigations Bureau and Thousand Oaks Special Enforcement Unit conducted an investigation into the robbery and identified one of the suspects in the robbery as William Hansen. In February 2016, Thousand Oaks Police Deputies arrested Hansen on unrelated charges. During a subsequent investigation, detectives located evidence linking Hansen to the home invasion robbery.

An extensive investigation into Hansen's involvement in the home invasion robbery ensued. In July 2018, Detectives with the Special Enforcement Unit presented the investigation to the Ventura County District Attorney's Office. The District Attorney's Office elected to file one count of 211 PC ' First Degree Residential Robbery, against Hansen. A warrant for Hansen's arrest was issued.

On August 9, 2018 Detectives with the Special Enforcement Unit arrested Hansen for the warrant while he was waiting to be released from the California Department of Corrections and Rehabilitation, where he had been in custody on unrelated charges. Hansen was transported to Ventura County, where he was bail was set at \$100,000.

Narrative:

On August 10th 2018, identity theft suspects were arrested in the City of Camarillo. They were in possession of personal identification information including, but not limited to, copies of credit cards and driver licenses of numerous victims. It was determined that the information had been stolen from business establishments and vehicle thefts.

On August 10th 2018, detectives with the Camarillo Police Special Enforcement Detail conducted a traffic stop on a vehicle for a mechanical violation in the 4400 block of Central Avenue in the City of Camarillo. The driver of the vehicle was identified as Cancio Soto and the passenger was identified as Janae Rodriguez, both residents of the Sacramento area.

It was determined that both parties were under the influence of a controlled substance and they were arrested for 11550(a) HS. During a search of the vehicle, approximately 20 copies of business invoices and other paperwork listing personal identifying information were located. The paperwork also contained copies of the numerous unknown victims' driver licenses and credit card copies. Based upon the identifying information located inside the vehicle and from information gleaned from interviewing the suspects, detectives believe Soto possessed the information for the purpose of committing identity thefts. In addition to the evidence of identity theft crimes, 3.6 grams of methamphetamine and drug paraphernalia was located inside the vehicle.

Following the arrests, detectives were able to contact several of the people listed on the paperwork located inside Soto's vehicle and confirmed this information had been stolen. One of the thefts was confirmed to have occurred in Santa Barbara County. Based upon these interviews, detectives believe Soto is involved in committing identify theft crimes in both Ventura County and Santa Barbara County.

Soto was booked into the Ventura County Pre-Trial Detention Facility for 11550(a) HS / Under the influence of a controlled substance, 11377(a) HS / Possession of a controlled substance, 11364 HS / Possession of drug paraphernalia and 530.5(c)(3) PC/ Possession of identifying information of 10 or more people with the intent to defraud. Rodriguez was booked into jail for 11550(a) HS / Under the influence of a controlled substance. Soto remains in custody with his bail set at \$50,000 and a court date on 08/14/18 in Ventura County Superior Court.

This investigation is on-going and Camarillo Police detectives are working with the Santa Barbara County Sheriff's Office to determine if Soto and Rodriguez are involved in additional identity theft crimes.

There are various ways citizens become identity theft victims, mail theft is the most common. The Camarillo Police Department would like to remind citizens to be aware of loose mail placed in unlocked mailboxes and theft of mail left in unlocked mailboxes for extended time periods. Please remember that Postal Inspectors across the country work hard to protect your mail. But with deliveries to more than 100 million addresses, the Postal Inspection Service can't do the job alone. You can protect your mail from thieves by remembering to pick up your mail promptly after delivery. Don't leave it in your mailbox overnight. If you're expecting checks, credit cards, or other negotiable items, ask a trusted friend or neighbor to pick up your mail. This diligence will assist in the prevention of becoming a victim of identity theft.

Narrative:

During the month of July, Detectives with the Thousand Oaks Police Department's Special Enforcement Unit conducted an investigation into the illegal transfer of firearms occurring in the City of Thousand Oaks. During the course of the investigation, detectives determined evidence of the illegal firearms transfer would be located in a residence in the 200 block of Windsong Street in the City of Thousand Oaks, and obtained a search warrant to search the residence.

On August 9, 2018, Detectives with the Thousand Oaks Special Enforcement Unit, Directed Enforcement Unit and East County Investigations Unit served the search warrant. During the service, they contacted Evan Brodsky and Jason Wilson outside the residence. During a search of the residence, detectives located evidence of the illegal firearms transfer, and also located eight handguns, three AR-15 rifles, 2 shotguns, multiple high capacity magazines and approximately 2600 round of ammunition. Detectives determined Brodsky was prohibited from possessing firearms and ammunition and arrested Brodsky for PC 29800(a)(1) ' Prohibited Person in Possession of a Firearm; PC 30305(a)(1) ' Prohibited Person in Possession of Brodsky into the Main Jail for the violations. Brodsky was released from custody on \$50,000 bail.

Detectives contacted Wilson and determined he was under the influence of a controlled substance. Detectives also searched property belonging to Wilson, and located approximately 15 grams of heroin, methamphetamine, narcotic paraphernalia and a switch-blade knife. Detectives also seized a large amount of U.S. currency that they believed was narcotics proceeds. Wilson was arrested for 11351 HS ' Possession of a Controlled Substance for Sales, 11352(a) HS ' Sales of a Controlled Substance, and several misdemeanor charges. Wilson was booked into the Main Jail for the violations, where he was released on \$105,000 bail.

Former Camarillo resident arrested for the 2017 murder of his younger brother.

On April 6, 2017, deputies from the Camarillo Police Department responded to a residence in the 2200 block of Marco Drive in Camarillo, in reference to a reported stabbing. Detectives from the Sheriff's Major Crimes Bureau also responded and assumed control of the investigation.

The preliminary investigation revealed that two brothers, Luis Aceves and Gilbert Aceves, were involved in a physical altercation which resulted in Gilbert sustaining multiple stab wounds. The incident occurred inside their family residence and no other witnesses were present.

Gilbert was immediately transported by ambulance to Los Robles Hospital for life-savings measures. Gilbert succumbed to his injuries and was pronounced deceased shortly after his arrival in the emergency room. Luis also sustained injury during the incident and was subsequently transported to another local hospital for treatment. Luis' injuries were deemed non-life threatening and he was discharged from the hospital the following morning.

During the following months, Major Crimes Detectives continued to investigate the incident and process evidence related to the homicide. Luis' activities were also closely monitored during the course of the investigation and it was discovered that several months following the homicide, he moved to Federal Way, Washington.

In April, 2018, Major Crimes Detectives traveled to Washington and worked with the King County Sheriff's Office to continue the investigation. Detectives ultimately obtained sufficient evidence to

showcase how the homicide was an act of murder with malice aforethought on the part of Luis.

In August, 2018, the case was presented to the Ventura County District Attorney's Office for criminal filing considerations. A felony warrant for Luis' arrest was subsequently issued for murder in violation of California Penal Code section 187(a), with an additional count for a special allegation of using a deadly weapon during the commission of a felony in violation of California Penal Code section 12022(b)(1). The bail for the warrant was set at \$3,000,000.00 by the Ventura County Superior Court.

On August 12, 2018, detectives obtained information that Luis had traveled back to Camarillo for reasons still unknown to investigators. On August 13, 2018, at approximately 1115 hours, Luis was located by Sheriff's detectives in the area of Las Posas Road and Arneill Road in Camarillo. Luis was arrested for the mentioned warrant and booked into the Pre-Trial Detention Facility without incident.

Luis Aceves appeared in Ventura County Superior Court today and his arraignment was continued until August 28, 2018.

Narrative:

On July 22, 2018, Sheriff's Deputies from the Headquarters Station responded to report of a stabbing that occurred the previous night. On July 21, 2018 at approximately 2130 hours, the victim was walking in the 200 block of Simon Way in El Rio when he was confronted by a suspect demanding money. When the victim stated he had no money, the suspect stabbed the victim in his forearm, causing injury. After the initial attack on Simon Way, the same suspect walked to the Valero gas station where he brandished a knife and yelled gang slogans at two additional victims.

After a three week investigation was concluded, the weapon believed to have been used in both attacks was located and a juvenile male suspect was identified. On August 10, 2018, a search warrant was executed along with a probation search leading to the arrest of the suspect, identified as a local gang member.

Narrative:

The Ventura County Narcotics Task Force concluded a four month long investigation into the Chaidez-Gonzalez crime family with the arrest of several individuals and service of search warrants related to heroin sales. This organization was found to be supplying heroin delivery services, as well as individual dealers, with bulk quantities of product for resale.

In May of this year, Ojai Patrol Officers became aware of a subject dealing heroin in western Ventura County known as Harold Mory. Shortly after obtaining this information, Narcotics Detectives saw Mory meet in Los Angeles County with Eliseo Gonzalez. Mory was arrested after he bought five ounces of heroin from Eliseo Gonzalez to sell to Ventura County Customers.

Narcotics Detectives continued to investigate Eliseo Gonzalez and learned he, along with Jose Rodriguez, were distributing heroin to multiple other Ventura County customers. Customers included: Sandra Monje, Mario Torres, Jeremy Mariott, and Clare Brown. All of whom were

arrested for various narcotics charges.

Detectives additionally discovered Eliseo Gonzalez and Jose Rodriguez were being supplied with heroin by Abraham Chaidez and Jose Gonzalez-Chaidez. Jose Gonzalez-Chaidez was found to be the head of the family-based organization, residing part time in Mexico and part time in the United States. Abraham Chaidez was seen on multiple occasions dealing heroin to Los Angeles based customers including Rubio Demetrio.

On August 10, 2018, search warrants were served at several locations in Los Angeles County.

Jose Gonzalez-Chaidez was arrested at an apartment in the 11900 block of Kling Street, Los Angeles for heroin sales. About 2 kilograms of heroin was found hidden in the residence. Suspected drug proceeds were also found in his residence.

Abraham Chaidez was arrested at his house in the 200 block of Avenue R3, Palmdale. Suspected drug proceeds were found at his residence.

Eliseo Gonzalez, his wife Maria Hermosillo, and their adult son, Luis Gonzalez, were arrested at their apartment in the 7100 block of Hazeltine Ave, Los Angeles. Two kilograms of heroin were found in Eliseo Gonzalez' vehicles during this investigation. Suspected drug proceeds were also found at their residence.

Jose Rodriguez was arrested at his residence in the 15100 block of Black Oak Court, Los Angeles. About two pounds of heroin was found in one of his vehicles. Suspected drug proceeds were also found at his residence.

The Thousand Oaks Police Department Special Enforcement Unit and Directed Enforcement Unit as well as the Los Angeles Police Department Van Nuys Division assisted in this investigation.

This Labor Day, and Every Day: Drive Sober or Get Pulled Over

Ventura County, California ' As we enter the final stretch of summer spending time at the pool or barbequing with friends and family, the Ventura County Sheriff's Office is driving home the importance of celebrating responsibly by not driving, or riding a motorcycle, impaired.

From Aug. 17 through Sept. 3, the Ventura County Sheriff's Office is participating in a high-visibility national enforcement campaign, *Drive Sober or Get Pulled Over*. During this period, Police and Sheriff's Departments statewide, along with the California Highway Patrol, will increase the number of officers on the road to stop suspected drunk or drug impaired drivers and motorcyclists. If you are caught driving or riding impaired, you will be pulled over and arrested.

The Cities of Camarillo, Moorpark, and Thousand Oaks will have a special emphasis during this 18-day mobilization to enforce all traffic violations by deploying DUI Saturation Patrols on most of the weekends during the mobilization period.

The enforcement campaign runs through the Labor Day holiday weekend, which is one of the deadliest times of year in terms of alcohol-involved traffic deaths. Sadly, one-third of all traffic deaths involve drunk drivers. According to the National Highway Traffic Safety Administration (NHTSA), 10,497 people were killed in alcohol-involved crashes, or one person every 50 minutes.

'It's up to drivers to make the smart decision and drive sober not just for this enforcement period, but every day', said Commander Dave Murray. 'This isn't about ticketing. This is a campaign to get the message out that driving impaired is illegal and takes lives.'

The Ventura County Sheriff's Office will show zero tolerance for impaired driving or riding and joins

efforts by the California Office of Traffic Safety (OTS) to educate drivers that 'DUI Doesn't Just Mean Booze.' If you take prescription drugs, particularly those with a driving or operating machinery warning label, you may be impaired enough to get a DUI. Marijuana can also be impairing and result in a DUI, especially in combination with alcohol or other drugs.

In the ten years from 2005-2015, the percentage of drivers in fatal crashes with an impairing drug other than alcohol in their system has risen from 26.2 percent to 42.6 percent. As far back as 2012, a roadside survey in California showed more drivers tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent).

During this national enforcement campaign, there will also be increased state and national messages about the dangers of riding impaired, which combined with enforcement, aims to drastically reduce drunk or drug impaired riding on our nation's roadways.

Motorcycles require specific training and skill. When a rider adds alcohol, marijuana or impairing prescription medication to the mix, it is not only illegal, but increases the risky nature of riding a motorcycle.

There are so many options out there to get home safely, so there is no excuse for getting behind the wheel when you are impaired.

To avoid a DUI and putting others, and yourself, at risk, The Ventura County Sheriff's Office has a few tips to stay safe on the roads:

- Always designate a sober driver.
- Use public transportation or a ride sharing service to get home.
- Use your community's sober ride program.
- Have a friend or family member who is about to drive buzzed or impaired' Take the keys away and make arrangements to get them home safely.
- Report drunk drivers call 911.

Funding for this DUI operation is provided to the Camarillo, Moorpark and Thousand Oaks Police Departments by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.

Narrative:

A 54-year-old transient was arrested for shooting a landscaper with a BB gun after an hour long stand-off with police.

On August 15, 2018, the victim reported being shot by a BB gun while landscaping in the area of the 2300 block of Borchard Road. Thousand Oaks Police patrol deputies responded to the location and contacted the victim. Deputies observed the victim had injuries to his face and neck area. The victim was treated for his injuries by medical personnel at the scene.

Through the investigation, deputies determined the shot likely came from a Recreational Vehicle (RV) parked in the area. Deputies attempted to contact the owner of the RV. The sole occupant, later identified as (S) Craig Hudgins, became hostile to the deputies and refused to exit the RV. Based upon Hudgins' hostile demeanor and the potential for Hudgins to be armed with a weapon, deputies created a perimeter and continued attempting to communicate with Hudgins. Communication via telephone was established and Hudgins agreed to exit the vehicle after approximately an hour of negotiations. Hudgins was promptly taken into custody. A search of the RV was conducted and a BB gun was recovered.

Approximately two months ago, Hudgins had been listed as a suspect in a vandalism where a BB gun was used to shoot out the window of a landscaper's truck window.

Hudgins was booked into the Pre-Trial Detention Facility and charged with both crimes. On August, 17, 2018, the Ventura County District Attorney's Office filed one count each of felony assault with a deadly weapon and misdemeanor vandalism. Hudgins remains in custody on \$20,000 bail.

Narrative:

On August 7, 2018, deputies were summoned to the 1200 block of Los Angeles Avenue in the unincorporated community of Saticoy in reference to a stabbing. Headquarters Patrol deputies, as well as investigators from the Sheriff's Gang Unit and Major Crimes Bureau were involved in the investigation. The preliminary investigation indicated that three Hispanic male suspects approached two victims, who were walking together, in the area of Los Angeles Avenue and Azahar Street. One of the suspects made threatening statements and remarks consistent with gang ideology while brandishing a knife at the victims. Upon seeing the suspect with the knife, both victims attempted to run away and were chased by all three suspects. One of the victims managed to escape assault/injury and fled the scene unharmed. The three suspects caught up with the second victim and attacked him in the area of Los Angeles Avenue and Violeta Street. The victim sustained stab wounds and a broken nose during the assault. The victim was treated and later released from a local hospital where his wounds were determined to be non-life threatening.

Detectives from the Headquarters Station, Major Crimes Bureau, and the Sheriff's Gang Unit conducted a follow-up investigation resulting in the identification of two suspects. On August 16, 2018, Gang Unit detectives arrested a 17 year old male and a 14 year old male for their involvement in the stabbing. Both suspects were later lodged at the Ventura County Juvenile Justice Center. The Ventura County District Attorney's Office has filed California Penal Code section 245(a)(1)- Assault with a Deadly Weapon and California Penal Code section 186.22(B)(1)(C)- Street Terrorism charges on both suspects. Investigators are actively working leads on the third suspect and an arrest is pending.

Narrative:

The Ventura County Sheriff's Office and allied agencies have arrested eight suspects as part of an ongoing investigation into a Pasadena/Los Angeles County based criminal street gang who commit residential burglaries in Ventura and Los Angeles Counties. Seven suspects have been charged or charges are pending for multiple counts of residential burglary and one suspect has been charged for being a felon in possession of a firearm. This burglary crew is believed to have committed more than 20 burglaries throughout Ventura and Los Angeles Counties. Investigators anticipate several more arrests as this investigation continues.

In April of 2018, The Thousand Oaks Police Department had a series of residential burglaries

that were occurring during daytime hours while the residents were not home. The residences were located in various parts of Thousand Oaks and in nearby unincorporated areas. It is believed the suspects conducted surveillance on the residences before committing the burglaries. All of the burglaries involved gaining access to the home via a rear window or glass door. During the investigation, investigators learned similar burglaries were occurring in various cities in Los Angeles County. Based on similarities in the burglaries, it was believed an organized group of suspects were involved in these crimes. Evidence was obtained linking Terrance Hall and Keith Callum to one of the residential burglaries in the unincorporated area of Thousand Oaks. Hall and Callum were determined to be members of a criminal street gang from Pasadena that have a history of committing residential burglaries among other crimes. It was also determined Hall was on parole for burglary.

Believing Hall and Callum were involved with several other unknown suspects, investigators from the Thousand Oaks Police Department, Ventura County Sheriff's Office Special Crimes Unit/Crime Analysis Unit, Los Angeles County Sheriff's Department's Major Crimes Bureau Burglary/Robbery Task Force, Los Angeles Police Department, Pasadena Police Department and San Bernardino Sheriff's Department Specialized Enforcement Division joined forces and started investigating Hall, Callum and their associates. As the investigation continued, Charles Smith (wanted for a 2016 burglary in Simi Valley), John Brown (on probation for drug sales), Kaela Travers (on parole for robbery), Preston Lee (on parole for robbery) and Kendall World (on probation for burglary) were all identified as being involved in residential burglaries that occurred in Ventura or Los Angeles Counties. An additional seven suspects associated with this burglary crew have been identified and additional arrests are anticipated over the next few weeks as those investigations are completed. It was determined at least one of the suspects was receiving information from a person employed by a residential cable provider about residences, homeowner activities, high value items located inside residences and where the homeowner's surveillance systems were located. Based on Charles Smith being wanted for a 2016 burglary in Simi Valley, investigators believe this burglary crew and the known and unknown associates have been committing residential burglaries in Ventura and Los Angeles Counties for guite some time.

On August 16, 2018 investigators served search warrants in Los Angeles and San Bernardino Counties. Numerous items of evidence linking the suspects to different crimes were located including 6 rifles, 3 handguns, large quantity of ammunition, stolen property, approximately 1 pound of marijuana, several hundred Xanax pills, and a large quantity of U.S. currency. In addition to the 5 burglaries that occurred in Ventura County, investigators have identified an additional 8 burglaries that occurred in Los Angeles County that the suspects are linked to. Investigators from Ventura and Los Angeles Counties are still combing through all of the evidence obtained from the search warrants and anticipate identifying more burglaries and arresting more suspects. In addition to the seven burglary suspects, Leslie Hall was arrested for being a felon in possession of firearm after investigators found two firearms and ammunition in a vehicle he owned. Leslie Hall is a convicted felon and prohibited from possessing firearms and ammunition.

The following suspects were booked into the Ventura County Jail: Keith Callum - \$1,000,000 bail, John Brown - \$1,000,000 bail, Kaela Travers - \$1,000,000 bail, Charles Smith \$1,000,000

bail, Terrance Hall \$3,000,000 bail. The following suspects were booked into the Los Angeles County Jail: Preston Lee ' No Bail, Kendall World - \$50,000. Leslie Hall was booked in Los Angeles County Jail for being a felon in possession of a firearm - \$20,000 bail.

Sheriff's detectives will follow-up to determine if the remaining registrants not contacted are out of compliance. The Sheriff's Office aggressively pursues prosecution of those sex registrants whom fail to comply with their registration requirements.

The Ventura County Sheriff's Office will be conducting similar sweeps on an ongoing basis, to verify registered sex offenders are living at their reported residences and in compliance with any probation or parole terms.

Narrative:

Once inside, the three suspects proceeded to steal several Apple IPhones and Apple laptop computers totaling approximately \$18,000.00. All three suspects ran out of the store, and in doing so, ran into a juvenile female customer causing her to fall to the ground. Other customers in the area tackled two of the suspects and detained them until Thousand Oaks Police Department Deputies arrived on scene. These two suspects were identified as Donte Sims of Antioch California and Timothy Terry also of Antioch California. The third suspect fled the mall and got into a waiting vehicle. Donte Sims and Timothy Terry were arrested for violating Penal Code section 459 ' burglary and PC 182(a)(1) ' criminal conspiracy.

At approximately 1536 hours, a Ventura County Sheriff patrol deputy observed a vehicle with three occupants traveling at a high rate of speed on eastbound State Route 118 in the City of Simi Valley and conducted a traffic stop. Upon contact, the patrol deputy identified the driver as Mona Benoit of Sacramento, passenger Tynisha Noel of Fresno, and passenger Edward Benton of Antioch. The patrol deputy ultimately arrested the driver for driving under influence of a controlled substance. A search of the vehicle resulted in the recovery of the Apple IPhones stolen from the Thousand Oaks Mall Apple store as well as Apple devices stolen during a burglary of an Apple store in Los Angeles County. Thousand Oaks Police Department Detectives identified this group as an Organized Retail Theft Crew and are conducting an investigation into this burglary as well as the burglary that occurred in Los Angeles County.

Detectives with the Thousand Oaks Police Department Major Crimes Sexual Assault Unit immediately responded to the school and took over the investigation.

Later that same afternoon, Detectives located Alaa Chaya at his place of employment, 1600 Block of Thousand Oaks Blvd, and interviewed him. At the conclusion of the interview, Detectives arrested Chaya for committing a lewd act upon a child, in violation of 288(a) PC & Oral Copulation of a Person Under 16 years old, a violation of 288a(b)(2) PC. Chaya was booked into the East County Jail. The Ventura County District Attorney's Office ' Sexual Assault Family Protection Unit filed three counts of Lewd or Lascivious Acts to a minor under 14 years old, a violation of 288(a) PC. Chaya posted \$150,000 bail and was released.

The Thousand Oaks Police Department Major Crimes Sexual Assault Unit continued to investigate Alaa Chaya. During the following months, their investigation revealed three additional victims. These victims were located and interviewed regarding their activities with Alaya Chaya. As a result of the continued investigation into Alaya Chaya, the Ventura County District Attorney's Office ' Sexual Assault Family Protection Unit filed numerous additional charges against Chaya.

In April of 2017, with the assistance of the Moorpark Police Department, the Sexual Assault Unit

arrested Alaa Chaya for attempted rape, a violation of 664/261(a)(2) PC and disorderly conduct (secretly recording someone with an expectation of privacy), a violation of 647(j)(2) PC. Chaya was arrested again booked into the East County jail.

In May of 2017, Detectives with the Sexual Assault Unit arrested Alaa Chaya for Unlawful Sexual Intercourse with a minor, a violation of 261.5(C) PC; Oral Copulation with a person under 18 years old, a violation of 288a(b)(1); Sending Harmful Matter to a minor, a violation 288.2(a) PC; and Possession of Child Pornography, a violation of 311.11(a) PC

In June of 2018, Alaa Chaya pled guilty to the following charges:

664/518 PC ' Attempted Extortion 288.2(a) PC ' Sending Harmful matter to a minor 261.5(c) PC ' Unlawful Sexual Intercourse with a person under 18 years of age. 2 Counts of 288(a) PC ' Lewd or Lascivious Acts to a person under 14 years of age

On August 20, 2018, the Ventura County Superior Court sentenced Alaa Chaya to State Prison for a fixed term of 7 years 8 months, he was also ordered to pay \$15,000 + in victim restitution, ordered to register as a sex offender upon his release from prison, and prohibited from owning or possessing any firearms. Chaya has remained in custody since his arrest in April of 2017, due to this he was also credited with over a year time served.

Driver's License/DUI Checkpoint Planned

Thousand Oaks, CA ' The Thousand Oaks Police Department Traffic Unit will be conducting a Driver's License/DUI Checkpoint on August 25, 2018, at an undisclosed location(s) within the city limits.

The deterrent effect of High Visibility Enforcement using both DUI checkpoints and DUI Saturation Patrols has proven to lower the number of persons killed and injured in alcohol or drug impaired crashes. Research shows that crashes involving an impaired driver can be reduced by up to 20 percent when well-publicized proactive DUI operations are conducted routinely.

DUI Checkpoints like this one are placed in locations based on collision statistics and frequency of DUI arrests, affording the greatest opportunity for achieving drunk and drugged driving deterrence. Locations are chosen with safety considerations for the officers and the public.

In California, alcohol involved collisions led to 1,155 deaths and nearly 24,000 serious injuries in 2014 because someone failed to designate a sober driver. Locally, over the course of the past three years, DUI collisions have claimed 6 lives and resulted in 85 injury crashes harming 112 of our friends and neighbors.

Officers will be looking for signs of alcohol and/or drug impairment, with officers checking drivers for proper licensing, delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving, which now accounts for a growing number of impaired driving crashes.

Studies of California drivers have shown that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol. Everyone should be mindful that if you're taking medication ' whether prescription or over-the-counter ' drinking even small

amounts of alcohol can greatly intensify the impairment affects.

Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, license suspensions and other expenses that can exceed \$10,000 not to mention the embarrassment when friends and family find out.

Funding for this checkpoint is provided to the Thousand Oaks Police Department by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration, reminding everyone to 'Report Drunk Driver ' Call 9-1-1'.

As the new school year begins in the next few days, the Camarillo Police Department would like to remind the public to be cautious as they travel near schools. As children and parents make their way to and from school, there will be an increase in traffic. To ensure children get to school safely, the Camarillo Police Department has the following suggestions:

Motorists:

- Slow down and observe the speed limit and traffic laws in school zones at all times. Camarillo Police Officers will be assigned to these areas to enforce traffic laws.
- Be very careful when driving on neighborhood streets and around school zones. Always expect the unexpected. Stay off of your cell phones or any other devices that may distract you as you travel.
- Be alert for children walking and biking as you back out of your driveway or leave your garage.
- If you are dropping your child off at school, do not stop in the street and let them out. Pull to the curb and let them out in a safe area.
- Watch for children on bicycles, especially at intersections.
- Follow directions of all crossing guards at crosswalks and near schools. Failure to do so can result in a citation.
- Stop your car when you see lights flashing on a school bus. Flashing red lights indicate that the bus is stopped and students are getting on or off. Vehicles in every lane need to stop. Do not start driving until the red lights stop flashing.
- Pay attention to Crossing Guards and do not enter the intersection until all pedestrians are clear and the Crossing Guard has lowered their Stop Sign

Bicyclists:

- Remind your children that bicyclists must follow the same rules of the road as vehicles
 do. They must stop for stop signs, red lights, and signal when turning.
- Any child under 18 years of age is required by law to wear an approved helmet when riding bicycles and scooters. Bicyclists not wearing helmets could be cited and the fine is over \$100.00.

Pedestrians:

- Never walk alone to school. Always walk with a friend or an adult.
- Only cross the street at a marked crosswalk.
- Look left, right, and left again before crossing and continue to be aware of your surroundings.
- Stay alert! Put cell phones, games, and other devices away until you arrive at your destination. If you wear Ear Buds, use them in one ear only, so that the other ear can hear sounds and possible hazards.
- Make eye contact with drivers prior to crossing when vehicles are approaching or stopped.

Hooper was arrested and booked into the Pre-Trial Detention Facility. The Ventura County District Attorney's Office filed the following felony charges:

Penal Code Section 664/187, Attempted Murder Penal Code Section 245(a)(1), Assault with a Deadly Weapon Penal Code Section 422, Criminal Threats Penal Code Section 21310, Carrying a Concealed Dirk or Dagger. Hooper remains in custody on \$500,000 bail. Hooper's next court appearance is scheduled for September 7th at 1:30PM.

Narrative:

On August 25, 2018, the Thousand Oaks Police Department Traffic Bureau conducted a DUI / Driver's License Checkpoint at one location in the City of Thousand Oaks. Vehicles were screened as they passed through the checkpoint locations. No arrests were made for DUI. Several citations were issued for unlicensed driver and/or for having a suspended/revoked driver's license.

The Checkpoint location was north bound Westlake Boulevard south of Hillcrest Drive from 8:10 p.m. to 2:30 a.m. Checkpoints are placed in locations that have the greatest opportunity for achieving drunk and drugged driving deterrence and provide the greatest safety for officers and the public.

DUI / Driver's License checkpoints have been shown to lower DUI deaths and related injuries. A major component of these checkpoints are the deterrent effects it has on those who might drive alcohol and/or drug impaired, bringing about more awareness and encouraging alcohol or drugged impaired drivers to use sober designated drivers.

According to the National Highway Traffic Safety Administration (NHTSA), checkpoints have provided the most effective documented results of any of the DUI enforcement strategies, while yielding considerable cost savings of \$6.00 for every \$1.00 spent. Ninety percent of California drivers approve of checkpoints.

During the listed Checkpoint Operation the following occurred:

- 893 vehicles entered the Checkpoint
- 812 vehicles were screened in the Checkpoint
- No DUI alcohol impaired arrests were made
- No DUI drug impaired arrests were made
- Six drivers were cited/arrested for operating a vehicle while unlicensed or for having a suspended/revoked driver's license
- A total of ten citations were issued

Driver's caught driving under the influence can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, and other expenses that can exceed \$10,000. That does not include embarrassment when family and friends find out.

The Thousand Oaks Police Department will be conducting another DUI/Driver's License checkpoint on September 8, 2018 (Saturday), in our ongoing commitment to lowering deaths and related injuries on our streets and highways.

The checkpoint was funded by a grant from the California OTS through NHTSA. Remember to report Drunk Drivers by calling 9-1-1.

The Camarillo Police Department would like to warn the public about a current scam. Several residents have received phone calls from someone claiming they owe taxes and that if they don't pay the taxes over the phone they will be arrested. This is a SCAM!

This message and many others like it ultimately say that you owe money and will be arrested if you do not call the phone number they provide. The voice in the message may be robotic or artificially generated.

What to do: Do not call the number back. If you are not sure if it is a legitimate call, you may call your local police department and request to speak to someone about a potential scam. Or, if you have not lost any money or given any of your personal information, you can notify the Federal Trade Commission (FTC) at https://www.ftccomplaintassistant.gov/ or call 877-382-4357.

If you have given out personal information, call the FTC at 877-438-4338.

If you experience any calls where you are suspicious that the caller is not legitimate, hang up. Do NOT give any personal information. You can perform an internet search on the number to determine if it is a robocall number. You may also be able to block the scammer from calling your phone (refer to your phone provider for more information).

There are many scams to be aware of and anytime anyone asks for you to pay with gift cards or asks for bank information, this is a major indicator that it is a scam. BE SAFE, contact your local law enforcement agency and ask! In Camarillo, call 805-388-5130 and ask to speak with Senior Deputy Virginia Tinoco.

Narrative:

On 08/23/2018, Detectives from the Ventura County Sheriff's West County Street Narcotics Team concluded a four month narcotic investigation into the methamphetamine and heroin trafficking activities of Richard Kevin Riley by executing search warrants on his person, vehicles, and residence. On 8/23/18 at approximately 1915 hrs., detectives served a signed narcotic search warrant at Riley's residence, located in the 14300 Block of Burbank Blvd in the City of Van Nuys.

Riley and his wife Rhonda Harvey were encountered inside the residence and detained pursuant to the search warrant. A search of the residence revealed the seizure of over 3 pounds of methamphetamine, 6 ounces of heroin, and 3 gallons of Gamma Hydroxybutric Acid (GHB). Evidence of narcotic sales were also seized which included digital scales, packaging material, pay and owe records, and a large sum of cash deemed to be narcotic proceeds. In addition to the narcotics, numerous loaded weapons were found throughout the house, totaling 5 handguns, 2 rifles and an assault rifle.

Riley was booked into the Ventura County Main Jail on numerous narcotic and weapons violations. His bail was set at \$160,000 and remains in the custody of the Sheriff's Department. His next scheduled court appearance is set for 9/06/2018 at 1:30 pm in Court Room 12. Harvey was also booked into the Ventura County Jail where she remains in custody. Her bail was set at \$90,000 and her next scheduled court appearance is set for 8/29/2018 at 1:30 pm in Court Room 14.

The West County Street Narcotics Team is comprised of narcotic detectives from the Ventura County Sheriff's Office, The Port Hueneme Police Department and the Oxnard Police Department. The California National Guard Counter Drug Task Force assisted the West County Street Team with this investigation.

On August 22, 2018, Thousand Oaks Police Department patrol deputies responded to a vandalism call in the 2800 block of Amber Wood Place in the City of Thousand Oaks. Deputies contacted the elderly victim and discovered that someone had poured a large amount of urine on the victim's sport utility vehicle. Upon review of the victim's home surveillance video, the victim and the deputies identified the possible suspect as James Eddy Pierson as the person who committed the act. Thousand Oaks Police Department Detectives conducted an investigation and found that a similar previous incident occurred at the victim's house where a large amount of urine was poured on the victim's front door mat. The victim also reported to detectives that he was unable to remove all the urine from his vehicle due to it getting into the interior of the vehicle and causing damage. The estimated total damage caused to the victim's vehicle was approximately \$2000.00. Thousand Oaks Police Department Detectives obtained a search warrant for Pierson's residence. The search warrant was served on August 30, 2018, and detectives located evidence linking Pierson to the vandalism. In addition, evidence was located in Pierson's home indicating he was a methamphetamine user. Pierson was transported to the Ventura County Jail and booked for felony vandalism and elder abuse. Pierson's bail was set at \$25,000.00 and he is scheduled to be arraigned for the charges on September 4, 2018, in Ventura County Superior
