On January 2, 2018, at approximately 1 a.m., Ventura County Sheriff's deputies responded to the 100 block of Conifer Circle for a 911 call of a residential burglary in progress. The victim reported that unknown suspects were attempting to enter his residence through a rear slider door.

Several patrol deputies including a K9 responded to the location and located a male juvenile suspect nearby. In addition, property from another unreported residential burglary was also located. Detectives from the East County Patrol Services Investigations Bureau responded and conducted an investigation. As a result of the investigation, Detectives identified a second male juvenile suspect. Detectives conducted a probation search at this juvenile's residence and located additional property from another unreported burglary in the neighborhood. Detectives subsequently identified a total of six residences that had been burglarized. All of the burglaries were committed while the homeowners were asleep. Both juveniles were lodged into the Ventura County Juvenile Justice Center for multiple counts of residential burglary.

Narrative:

Deputies from West County Patrol, Fillmore Station, responded to a report of shots fired from a moving vehicle in the area of Briggs Road, north of Santa Paula Street. Deputies checked the area and found no evidence of a weapon being fired. While checking the area, deputies made contact with officers from the California Highway Patrol who were investigating an overturned Dodge Ram in the same area. The officers advised that a large amount of narcotics, a loaded pistol magazine, and spent .40 caliber shell casings were found inside the vehicle.

On 12/31/2017, Eric Escamilla attempted to report the Dodge Ram as a stolen vehicle to the Ventura Police Department. Escamilla was unable to provide sufficient information that the vehicle was stolen. Detectives from the Sheriff's Gang Unit conducted a follow-up investigation at Escamilla's residence. During an interview with detectives, Escamilla admitted to driving the Dodge Ram while intoxicated and fleeing the scene after he was involved in a single vehicle traffic accident. Escamilla also admitted ownership to the narcotics, loaded pistol magazine, and spent .40 caliber shell casings found in his vehicle.

Narrative:

Monday, January 8, 2018 will usher in the first significant storm for Southern California this season. As the storm has moved closer to the region, the rainfall rates have been estimated to bring intensities of a half inch to one inch per hour in the foothills of Western Ventura County overnight Monday into Tuesday between 10:00 pm and 6:00 am. That time period is expected to be the peak of the storm with rain tapering off after 6:00 am Tuesday. Additional rain with possible high intensity short term downpours could be seen throughout Tuesday.

Many areas in the county are susceptible to mudslides even without the impact the Thomas Fire has had on hillsides. The Thomas Fire has stripped hundreds of square miles of mountains and hillsides leaving no vegetation to hold the soil in place. According to geologists who have surveyed the burn area, Monday's storm could bring enough rain to cause mud and debris flows in areas that were impacted by the Thomas Fire. Members of the community need to be aware that debris flows can occur suddenly and without warning.

In anticipation of this and other storms this season, inmates at the Todd Road Jail have been steadily filling sandbags at the rate of 2,000 per day. The Ventura County Sheriff's Office has also acquired 40,000 surplus sandbags from the Department of Defense to distribute to the public

during this rainy season. Ventura County Public Works has purchased additional sandbags and they will be available to the public for free, so residents and business owners can help to protect their properties from mud and debris flows. The sandbags are being distributed through Ventura County fire stations in and around the Thomas Fire burn area, and they will have supplies on hand so residents can also fill sandbags in the event the pre-filled bags run out. Residents can get sandbags from local fire stations during normal business hours. When they are not involved in an emergency response, firefighters will be available to assist residents.

Residents are asked to bring their own shovel.

The Sheriff's Office of Emergency Services will open their Emergency Operations Center Monday morning, and has held planning meetings in advance of this rain event with our partner agencies,

such as the Ventura County Fire Department, Ventura County Public Works, County Chief Executive Office, city leaders throughout the region, and the American Red Cross.

Residents need to be prepared to evacuate if necessary. We had great success with our notification systems during the Thomas Fire, but no system is perfect. Be aware, stay tuned-in and help your neighbors, friends and families stay up to date. If evacuations are necessary the initial Red Cross shelter location will be at the Ventura County Fairgrounds '10 W Harbor Blvd, Ventura

Narrative:

An inmate incarcerated at the Ventura County Pre-Trial Detention Facility was arrested yesterday for solicitation of murder. David Beech was already in custody for possession of child pornography and multiple counts of committing lewd acts against children. Among his intended targets of the murder plot were victims of his previous sexual assaults.

In October 2017, investigators received information revealing Beech intended to have several people murdered. The information prompted an investigation by the Classification Unit and the Sheriff's Major Crimes Bureau.

Investigators learned Beech went through a series of calculated steps and overt acts to carry out his plan, which included the solicitation and employment of a 'hitman' to perpetrate the crimes on

his behalf. Unbeknownst to Beech, the individual he subsequently hired to commit the murders was actually an undercover police officer.

Investigators determined Beech's motivation to have these individuals murdered was so they would be unable to testify in his trial and, therefore, his current charges would be dropped. The likely result would have led to Beech's release from custody.

Following Beech's arrest, the Ventura County District Attorney's Office has filed four counts of solicitation of murder. Beech's arraignment on those charges is pending.

Beech, a 58-year-old Simi Valley resident, has been in custody since January 9, 2015 awaiting

trial on the charges of child pornography and lewd acts. His bail has been set at \$1.4 million.

On 12-28-17, Sheriff's Major Crimes detectives arrested Erik Santoyo for an armed bank robbery that occurred on 08-31-17, at the Citibank branch located in the 400 block of Arneill Road in Camarillo. Santoyo was arrested at the Pre-Trial Detention Facility in Ventura where he was already in custody for a separate bank robbery that occurred at the Ventura County Credit Union in the city of Moorpark on 12-15-17.

On 08-31-17, Camarillo patrol deputies responded to a call of an armed bank robbery at the Citibank branch. It was discovered that a white or Hispanic male entered the bank and produced a hand written note demanding money. During the robbery, the suspect displayed a semiautomatic handgun to the bank teller and fled with cash. Sheriff's Major Crimes detectives responded to investigate the robbery.

On 12-15-17, another bank robbery occurred at the Ventura County Credit Union in Moorpark. Based on evidence located at the scene of the Moorpark robbery, Erik Santoyo was quickly identified as a suspect. Major Crimes detectives identified several similarities between Santoyo and the suspect in the Citibank robbery. Major Crimes detectives worked in conjunction with investigators from the Sheriff's East County station to locate Santoyo and take him into custody. Search warrants were served at several locations related to Santoyo and evidence linking him to both robberies was recovered.

The Ventura County District Attorney's Office has filed one felony count of armed robbery against Santoyo for the Citibank robbery. He appeared in court on 12-29-17 and entered a plea of not guilty. His next court appearance is scheduled for 01-19-18. His bail has been set at \$50,000.

Thousand Oaks, CA ' The Thousand Oaks Police Department Traffic Unit will be conducting a Driver's License/DUI Checkpoint on January 13, 2018 at an undisclosed location(s) within the city limits.

In recent years, California has seen a disturbing increase in drug-impaired driving crashes. The Thousand Oaks Police Department supports the new effort from the Office of Traffic Safety that aims to educate all drivers that 'DUI Doesn't Just Mean Booze.' If you take prescription drugs, particularly those with a driving or operating machinery warning on the label, you might be impaired enough to get a DUI. Marijuana can also be impairing, especially in combination with alcohol or other drugs, and can result in a DUI.

The deterrent effect of High Visibility Enforcement using both DUI checkpoints and DUI Saturation Patrols has proven to lower the number of persons killed and injured in alcohol or drug impaired crashes. Research shows that crashes involving an impaired driver can be reduced by up to 20 percent when well-publicized proactive DUI operations are conducted routinely.

DUI Checkpoints like this one are placed in locations based on collision statistics and frequency of DUI arrests, affording the greatest opportunity for achieving drunk and drugged driving deterrence. Locations are chosen with safety considerations for the officers and the public.

In California, alcohol involved collisions led to 1,155 deaths and nearly 24,000 serious injuries in 2014 because someone failed to designate a sober driver. Locally, over the course of the past three years, DUI collisions have claimed 8 lives and resulted in 91 injury crashes harming our friends and neighbors.

Officers will be looking for signs of alcohol and/or drug impairment, with officers checking drivers for proper licensing, delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving, which

now accounts for a growing number of impaired driving crashes.

Studies of California drivers have shown that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol. Everyone should be mindful that if you're taking medication ' whether prescription or over-the-counter ' drinking even small amounts of alcohol can greatly intensify the impairment affects.

Drivers are encouraged to download the Designated Driver VIP, or 'DDVIP,' free mobile app for Android or iPhone. The DDVIP app helps find nearby bars and restaurants that feature free incentives for the designated sober driver, from free non-alcoholic drinks to free appetizers and more. The feature-packed app even has social media tie-ins and even a tab for the non-DD to call Uber, Lyft or Curb.

Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, license suspensions and other expenses that can exceed \$10,000 not to mention the embarrassment when friends and family find out.

The Thousand Oaks Police Department will step up pedestrian safety enforcement operations on Wednesday Jan 10, 2018 with focused enforcement on collision causing factors involving motorists and pedestrians. Routine traffic patrols will focus efforts in trouble spots while special targeted patrols will also be deployed to crackdown on drivers and pedestrians who violate traffic laws meant to protect all roadway users.

The department has mapped out locations over the past several years where pedestrian involved collisions have occurred along with the violations that led to those crashes. Officers will be looking for traffic offenses made by drivers and pedestrians alike that can lead to life changing injuries. Special attention will be directed toward drivers speeding, driving distracted, making illegal turns, failing to stop for signs and signals, failing to yield to pedestrians in cross walks or any other dangerous violation. Additionally, enforcement will be taken for observed violations when pedestrians cross the street illegally or fail to yield to drivers who have the right of way. Pedestrians should cross the street only in marked crosswalks or intersections.

Pedestrian fatalities are rising in California as more people use non-motorized means of transportation. In 2016, California witnessed 867 pedestrian deaths accounting for nearly 24 percent of all roadway fatalities, much higher than the national average of 15 percent.

A national study reveals that pedestrians and drivers do not obey laws and signals consistently and many often use cell phones, text and listen to music while walking or driving. Only 60 percent of pedestrians said they expected drivers to stop when they were in crosswalks, even though they have the right-ofway. The following safety tips can save lives and stop this tragedy witnessed far too often in Thousand Oaks: Drivers can:

- Look out for pedestrians, especially in hard-to-see conditions such as at night or in bad weather.
- Slow down and be prepared to stop when turning or entering a crosswalk where pedestrians are likely to be.
- Stop at the crosswalk stop line to give drivers in other lanes an opportunity to see and yield to the

pedestrians too.

- Be cautious when backing up ' pedestrians, especially young children, can move across your path.

Pedestrians can:

- Be predictable. Follow the rules of the road, cross at crosswalks or intersections, and obey signs and signals.
- Walk facing traffic and as far from traffic as possible if there is no sidewalk.
- Pay attention to the traffic moving around you. This is not the time to be texting or talking on a cell phone.

- Look left-right-left before crossing a street.

of a possible shoplifting in progress at a local Department Store in the City of Moorpark. Upon their arrival, deputies spoke with Store Loss Prevention and learned they were monitoring three individuals they suspected were committing identity theft, by using forged or fictitious credit cards.

the neighboring community of Agoura Hills in Los Angeles County. During the preparation for the

search warrant, detectives learned that the Jail Intelligence Unit of the Los Angeles County Sheriff's Department was investigating the same suspects and was preparing a search warrant for the same residence, as well as a neighboring residence, for an unrelated narcotics investigation.

As a result, the investigation became a collaborative effort between the LA County Sheriff's Department and the Ventura County Sheriff's Office. On January 11

investigators from the LA County Sheriff's Department served a search warrant at one of the residences while detectives from the Ventura County Sheriff's Office simultaneously served a search warrant at the neighboring address. In total, 12 persons were detained between both addresses.

The search warrant resulted in the arrest of four individuals by investigators from the LA County Sheriff's Department for narcotics charges and outstanding arrest warrants. Detectives from the Ventura County Sheriff's Office arrested three individuals for identity theft related charges.

Detectives from Ventura County also obtained a significant amount of evidence to support the furthering of their identity theft investigation, including embossers, skimmers, computers and blank

credit cards.

Ewao Butler of Los Angeles was arrested for several identity theft related charges and is being held at the Ventura County jail in lieu of \$50,000.00 bail. Laura Lyons of Agoura Hills also was arrested for several identity theft related charges and is being held at the Ventura County jail in lieu of \$50,000.00 bail. A third individual was arrested but later released with no charges.

The investigation is ongoing and additional arrests are expected in this case.

January DUI / Driver's License Checkpoint

On January 13, 2018, the Thousand Oaks Police Department Traffic Bureau conducted a DUI / Driver's License checkpoint at two locations in the City of Thousand Oaks. Two arrests for DUI were made. Traffic citations were also issued to several drivers.

The first location was eastbound Hampshire Road at Westlake Blvd. The second location was westbound Lynn Road at Capitan Street. Checkpoints are placed in locations that have the greatest opportunity for achieving drunk and drugged driving deterrence and provide the greatest safety for officers and the public.

In recent years, California has seen a disturbing increase in drug-impaired driving crashes. The Thousand Oaks Police Department supports the new effort from the Office of Traffic Safety that aims to educate all drivers that "DUI Doesn't Just Mean Booze." If you take prescription drugs, particularly those with a driving or operating machinery warning on the label, you might be impaired enough to get a DUI. Marijuana can also be impairing, especially in combination with alcohol or other drugs, and can result in a DUI.

Studies of California drivers have shown that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol.

During the listed Checkpoint Operation the following occurred:

- ' 464 vehicles were screened
- ' 2 DUI (adult) arrest-alcohol suspected
- ' 0 DUI (adult) drug impaired arrests
- ' O Arrested on other Criminal Charges
- ' 5 Drivers were cited/arrested for operating a vehicle while unlicensed or suspended/revoked
- ' A total of 8 citations were issued

Drivers are encouraged to download the Designated Driver VIP, or "DDVIP," free mobile app for Android or iPhone. The DDVIP app helps find nearby bars and restaurants that feature free incentives for the designated sober driver, from free non-alcoholic drinks to free appetizers and more. The feature-packed app even has social media tie-ins and even a tab for the non-DD to call Uber, Lyft or Curb. For more information, visit http://www.ots.ca.gov/pdf/DDVIP-App.pdf.

Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, license suspension and other expenses that can exceed \$10,000 not to mention the embarrassment when friends and family find out.

The Thousand Oaks Police Department will be conducting another DUI/Driver's License checkpoint on March 24, 2018 (Saturday), in our ongoing commitment to lowering deaths and related injuries on our streets and highways.

The checkpoint was funded by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration, reminding everyone to 'Report Drunk Driver' Call 9-1-1.'

Narrative:

Five people have been arrested for their suspected involvement in a gang-related assault that sent two victims to the hospital.

On the evening of December 15, 2017, there was a small gathering of people in the area of Avenida Del Platino and Calle Diamonte in Newbury Park. The gathering was described as an informal memorial service for David Smith who was shot and killed in the same area on November 30, 2017. An argument began during the gathering and several suspected gang members assaulted three non-gang members. One victim was attending the gathering and the other two came to the aid of the first victim. During the assault one victim was cut with a sharp object, another suffered a serious injury to his mouth and the third was badly beaten. The victims with the cut wound and mouth injury were both transported to the Los Robles Hospital where they were treated for their injuries and released. The subsequent investigation led to the identification of four suspects who were involved in the assault and one suspect who made statements during the incident intended to intimidate the victims and prevent them from cooperating with the police.

On January 4, 2018, Jessica Macias and a male juvenile were arrested in Newbury Park for assault with a deadly weapon and gang allegation charges. Macias was booked into the

Ventura County Jail and later released on bail. The male juvenile was lodged into Juvenile Hall where he remains in custody awaiting trial.

On January 12, 2018, Joe Higareda and Alexis Martinez were arrested in Simi Valley for assault with a deadly weapon and gang enhancement charges. Both were booked into the Ventura County Jail where they remain in custody awaiting trial. Fabian Higareda was arrested in Simi Valley this same day for dissuading a witness and gang enhancement charges. He was booked into the Ventura County Jail and later released pending further investigation.

During the month of January 2018, detectives with the Ventura County Sheriff's Office conducted an investigation that led to the arrests of two subjects and the recovery of ten illegally possessed firearms.

On January 17, 2018, detectives with the Ventura County Sheriff's Office conducted an investigation involving the illegal sales and transfer of firearms. Detectives identified John Flores and Camilo Zamora as the two subjects involved. Detectives subsequently contacted Flores and Zamora in the City of Oxnard and arrested them after a brief vehicle and foot pursuit. Detectives recovered several firearms during the contact. Additionally, Flores possessed a small amount of heroin and syringes used to inject it.

Detectives later executed a search warrant in the 1900 Block of North 6

Flores and Zamora were both booked at the Pre-Trial Detention Facility for various charges. Flores' charges include violations of Penal Code sections 29800(a)(1)-Felon in possession of firearm, 30305(a)(1)-Felon in possession of ammunition, Health and Safety Code sections

th Place in the City of Port Hueneme, where detectives seized several additional firearms and ammunition. Detectives followed up on information and searched a second location in the City of Oxnard. Detectives seized a total of ten firearms, which included six handguns and four rifles. Based on the investigation, detectives determined Flores and Zamora both have extensive criminal histories which include felony convictions that prohibit them from owning and or possessing any firearms or ammunition. Additionally, they are both on active Ventura County probation for various charges.

11350(a)-Possession of a controlled substance, 11364(a)-Possession of drug paraphernalia and Vehicle Code section 2800.2(a)-Felony evading. Zamora's charges include violations of Penal Code sections 29800(a)(1)-Felon in possession of firearm, 30305(a)(1)-Felon in possession of ammunition, 25400(a)(3)-Carry concealed firearm in vehicle and 148(a)1)-Resist, obstruct or delay a police officer. Flores' and Zamora's bail was set at \$200,000.00. They are currently in custody awaiting court proceedings. The investigation into the recovered firearms is ongoing.

OXNARD, Ca., On January 19, 2018, detectives from the Ventura County Sheriff's West County Narcotic's Team concluded a two-month-long narcotic investigation into Oxnard resident, Juan Nava, who was being investigated for the sales of methamphetamine to residents of Ventura County.

Detectives executed a signed narcotic search warrant for Nava's residence. Fifteen people, including three children, were found residing in the house and various sheds and outbuildings located on the property. These individuals were detained during the investigation and search of the residence.

The West County Street Team was assisted by the Oxnard Police Department's Neighborhood Policing Team and the California National Guard ' Counter Drug Task Force.

During the search of Nava's residence, Detectives located narcotics paraphernalia indicative of narcotics sales. Juan Nava was not located at the residence. However, three other individuals were arrested for various narcotic violations, including possession of methamphetamine. A fourth man, believed to be Nava's son, was arrested for an outstanding misdemeanor warrant. All four

men were booked at the Ventura County Main Jail.

The West County Street Narcotics Team is comprised of narcotic detectives from the Ventura County Sheriff's Office, the Oxnard Police Department and the Port Hueneme Police Department. The California National Guard Counter Drug Unit is a partner agency with the Narcotic Task Force and assisted with the service of this search warrant.

Due to the high number of individuals residing on the property, coupled with the high safety concerns associated with a narcotic search warrant, the 15 residents were detained in front of the home. This was done so the investigating officers could safely search the residence as authorized by the search warrant.

Many people who witnessed the incident took to social media to speculate that an immigration raid was taking place and that Immigration and Customs Enforcement (ICE) agents were involved.

This was incorrectly reported. ICE agents did not directly or indirectly participate in this investigation. This was solely a narcotic sales investigation in an effort to make the community a safer place.

Mitchell Hahn was arrested today in Granada Hills following a battery investigation wherein Hahn was identified as the suspect. The victim, Alan Pancratz, suffered significant injuries requiring hospitalization resulting from the battery.

Due to the quick thinking and diligent actions of local residents who witnessed the crime; including a video recording which captured the incident, investigators obtained evidence which identified Hahn as the suspect who committed the battery against Pancratz.

During the early morning hours of January 22, 2018, Hahn was arrested by Sheriff's investigators near his residence. Following Hahn's arrest, investigators served a search warrant at Hahn's residence in the 17000 block of Los Alimos St. in Granada Hills. During the service of the search warrant, additional items of evidence were located further connecting Hahn to the crime. Hahn was booked at the Pre-Trial Detention Facility in Ventura for Penal Code section 243(d) - causing great bodily injury

in Ventura County Superior Court for arraignment on January 24, 2018.

A man arrested last week in the Ojai Valley is awaiting extradition by the US Marshal's Office for one count of murder and one count of attempted murder in the state of Colorado. Greg Boren was arrested in Meiners Oaks January 16, 2018 for narcotics violations and was booked at the Pre-Trial Detention Facility in Ventura. He had no identification at the time, and he gave the arresting deputy the name of Kyle Smith.

DUI/Driver's License Checkpoint Planned this Weekend

Camarillo, CA ' The Camarillo Police Department Traffic Bureau will be conducting a DUI/Driver's License Checkpoint on 1/27/18, at an undisclosed location within the city limits between the hours of 6: p.m. to 2:30 am.

In recent years, California has seen a disturbing increase in drug-impaired driving crashes. The Camarillo Police Department supports the new effort from the Office of Traffic Safety that aims to educate all drivers that "DUI Doesn't Just Mean Booze." If you take prescription drugs, particularly those with a driving or operating machinery warning on the label, you might be impaired enough to get a DUI. Marijuana can also be impairing, especially in combination with alcohol or other drugs, and can result in a DUI.

The deterrent effect of High Visibility Enforcement using both DUI checkpoints and DUI Saturation Patrols has proven to lower the number of persons killed and injured in alcohol or drug impaired crashes. Research shows that crashes involving an impaired driver can be reduced by up to 20 percent when well-publicized proactive DUI operations are conducted routinely.

DUI Checkpoints like this one are placed in locations based on collision statistics and frequency of DUI arrests, affording the greatest opportunity for achieving drunk and drugged driving deterrence. Locations are chosen with safety considerations for the officers and the public.

In California, alcohol involved collisions led to 1,155 deaths and nearly 24,000 serious injuries in 2014 because someone failed to designate a sober driver. Over the course of the past three years, Camarillo Police Department officers have investigated 168 DUI collisions which has claimed one life and resulted in another 52 injuries.

Officers will be looking for signs of alcohol and/or drug impairment, with officers checking drivers for

proper licensing, delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving, which now accounts for a growing number of impaired driving crashes.

Studies of California drivers have shown that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol. Everyone should be mindful that if you're taking medication 'whether prescription or over-the-counter 'drinking even small amounts of alcohol can greatly intensify the impairment affects.

Drivers are encouraged to download the Designated Driver VIP, or "DDVIP," free mobile app for Android or iPhone. The DDVIP app helps find nearby bars and restaurants that feature free incentives for the designated sober driver, from free non-alcoholic drinks to free appetizers and more. The feature-packed app even has social media tie-ins and even a tab for the non-DD to call Uber. Lyft or Curb.

Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, license suspensions and other expenses that can exceed \$10,000 not to mention the embarrassment when friends and family find out.

In an effort to recognize certain hazards while driving, the Traffic Bureau has started a monthly traffic awareness reminder program, addressing a traffic topic each month. While we focus on a specific topic each month, it's always imperative to constantly strive to follow all rules of the road. The month of February is dedicated to "Buzzed Driving is Drunk Driving".

California law states it is illegal to drive a motor vehicle with a blood alcohol level equal to or greater than .08%. In addition, it is illegal to operate a motor vehicle while under the influence of a drug or the combined influence of alcohol and drugs.

Here are some important facts you should know:

- 1. Impairment is not reliant upon the type of alcohol consumed, rather the number of drinks over a certain period of time. Despite myths and misconceptions, coffee, a cold shower, or exercise will not make a person more sober; only time will.
- 2. On average, a drunk driver will drive 80 times under the influence before their first arrest.
- 3. Every 51 minutes in America, someone is killed in a drunk driving crash. That equates to 27 people every day. Offer to be a designated driver to ensure that everybody gets home safe.
- 4. For drivers under 21, the U.S. has a No Tolerance policy that does not allow any alcohol to be in the blood system while behind the wheel. The consequences could include expensive fines, loss of license, or jail.

5. One recent study found that drivers who were "minimally buzzed" or "buzzed" were often to blame for fatal accidents. The term "minimally buzzed" includes drivers who had a BAC of .01, which is well within the legal limit. Researchers examined more than 570,000 fatal accidents. The results: Drinking and driving with

Narrative:

On 09/26/2017, two robberies occurred in the City of Camarillo. At about 3:15 A.M., a masked male entered 7-Eleven on Carmen Drive, near Daily Drive, while armed with a weapon. The suspect threatened and assaulted the clerk before stealing cash from the register and fleeing the store. Fortunately, the clerk did not sustain any injuries.

At about 09:15 A.M. (just 6 hours after the first robbery), a masked male suspect entered the Baja Fresh Restaurant located in the 1800 block of E. Daily Drive in Camarillo. Upon entering the restaurant, the suspect brandished a firearm and threatened several employees. Ultimately, the suspect stole cash from the cash drawer and fled the area on foot.

Over the next couple days, detectives identified (S) Martin Prado as a possible suspect in both robberies. Detectives also identified an associate of Martin Prado as a possible accomplice to at least one of the robberies. Martin Prado is currently on probation with search terms for an unrelated offense.

On 10/11/2017, detectives executed a probation search at Prado's residence in Camarillo and a search warrant at a residence in Port Hueneme. During the searches, evidence linking Prado and his associate to the 7-Eleven robbery was located and both were taken into custody.

Over the next few months, detectives continued their investigation and located additional evidence linking Prado to the Baja Fresh robbery.

On 01/31/2018, Prado was arrested for PC 211 ' [Robbery] and PC 29815 ' [Possession of a Firearm While on Probation]. He was still in custody for the 7-Eleven robbery at the time of the arrest for the Baja Fresh robbery. Prado is scheduled to appear in Ventura County Superior Court for arraignment on the Baja Fresh robbery on 02/02/2018. Prado's bail is currently set at \$65,000 for the 7-Eleven robbery and \$50,000 for the Baja Fresh robbery.

Kickoff on America's favorite past time is just about ready to start. For many football fans, when it's time for Super Bowl LII, everyone's a fan'

Impaired driving near or above the .08 BAC limit can be deadly, and even small amounts of alcohol can impair judgement to make driving unsafe. In 2016, the National Highway Traffic Safety Administration (NHTSA) reported there were 10,497 fatalities in motor vehicle traffic crashes involving drunk drivers nationwide. California recorded 1,059 DUI deaths at .08 BAC or above according to the NHTSA.

The Ventura County Sheriff's Office supports the new effort from the Office of Traffic Safety that aims to educate all drivers that "DUI Doesn't Just Mean Booze." Drug-impaired driving is a problem on California roadways. Like drunk driving, drugged driving is impaired driving, which means it is dangerous and illegal. Whether the drug is legally prescribed, an illicit drug or marijuana, driving while drug impaired poses a threat to the driver, vehicle passengers, and other motorists, and driving high can lead to a DUI.

"Be sure to have a game plan for the night so friends and family know who the designated driver is," said Captain Jeremy Paris from the Camarillo Police Department. "We want to encourage folks to turn over their keys to a sober driver before the game begins. Impaired driving can result in serious crashes, injuries or death. If you don't have an 'MVP' to make sure folks get home safely, consider other ride options."

There are many other ways to ensure a safe ride home besides relying on a friend. The OTS DDVIP app is now available for free download on iOS and Android devices. The app offers enhanced features, allowing users to search all participating bars and restaurants throughout California. Additionally, the app users can

Narrative:

Detectives discovered a sophisticated money counterfeiting laboratory inside a house Monday while serving a search warrant in San Bernardino.

The investigation began on the evening of January 28, 2018, when patrol deputies from the Moorpark Sheriff's Station responded to Kohl's department store regarding counterfeit bills being passed by two customers. Deputies learned the two men were buying expensive items using fake \$100 bills.

Deputies detained Donald Hagee and Mitchell Wagers, who had a total of \$15,000 in counterfeit bills in their possession. The men were with a third suspect identified as Crystina Graciano. The two men also had narcotics in their possession, and Wagers was wanted for an outstanding parole warrant.

On January 29, 2018, Moorpark detectives began a follow-up investigation on the case. They learned of a location in the city of San Bernardino, where the counterfeit bills were being manufactured.

On Monday, detectives from the Moorpark Investigations Bureau, Sheriff's Special Crimes Unit and the Thousand Oaks Special Enforcement Bureau as well as a Special Agent from the United States Secret Service served a search warrant at a residential business in the 1800-block of

South Tippecanoe Avenue in San Bernardino. Investigators discovered the location was a laboratory used to manufacture US currency and credit cards.

The Secret Service Special Agent described the lab as one of the largest and most sophisticated labs he had seen in his career.

Detectives seized several computers, laser printers, plastic ID card printers, plastic card cutters, precision cutting tables and tools, electric heating and drying devices, dry powder ink sets, thousands of dollars of counterfeit currency in varying degrees of completion, bill tracings, washed US currency, silkscreen printing plates, large quantities of printer ink, fluorescent light bill verifiers. They also found personal identifying information of several individuals, including driver's licenses and social security cards and a loaded 9mm semi-automatic pistol.

Hagee is currently in custody at the Ventura County Pre-Trial Detention Facility for conspiracy and forgery, as
