On February 28, 2018, at approximately 2:30 PM, Denise Dale went into Camarillo Heights Elementary School and stated she was a relative who was supposed to pick up the victim. Based on the protocols set in place, school staff immediately advised Camarillo Police. Within minutes, several deputies arrived on scene and detained Dale at her vehicle parked outside of the school. After a thorough investigation, Dale was arrested for 647.6(a) PC- Child Annoying. There was no physical contact between Dale and the victim. Dale was booked into the Ventura County Jail without incident.

The Pleasant Valley School District and Camarillo Police Department would like to take this opportunity to remind parents that although we live in a safe area, please speak to your children about 'Stranger Danger'. Part of this discussion should include that anyone the child does not know is a stranger and they should practice Stranger Danger precautions. Encourage your child,

if possible, to walk in pairs with a buddy to school, and never approach or get into a vehicle when

The Thousand Oaks Police Department strives to promote traffic safety within the community. In an effort to recognize certain hazards while driving, the Traffic Bureau has started a monthly traffic awareness reminder program, addressing a traffic topic each month. While we focus on a specific topic each month, it's always imperative to constantly strive to follow all rules of the road. The month of March is dedicated to 'Bicycle Safety'.

Each year, hundreds of bicyclists in California are involved in a collision with a motor vehicle. Most of the time, the bicyclist is the one who will receive the most injuries. With that in mind, we all need to know the importance of sharing the road with one another. Motorists and bicyclists both need to do their part in keeping each other safe.

Here are some important facts you should know:

- 1. California vehicle code section 21202(a) states: Any person operating a bicycle upon a roadway at a speed less than the normal speed of traffic moving in the same direction at the same time shall ride as close as practicable to the right ' hand curb or edge of the roadway.
- 2. A bicycle ridden at night must be equipped with a lamp emitting a white light. There must also be a red reflector on the rear of the bicycle that must be visible from 500 feet when directly in front of a motor vehicle whose headlights are on.

- 4. No person shall drive a motor vehicle in a bicycle lane established on a roadway except to park where parking is permitted, to enter or leave the roadway, or to prepare for a turn within a distance of 200 feet from the intersection.

8. Bicyclists obey the rules of the road because they travel along the roadway with other motorists. It is important to note drivers and bicyclists must share the road. When making turning movements in a car or on a bike, use caution, be seen (appropriate lighting after dark) and be predictable.

The Thousand Oaks Traffic Bureau urges citizens to drive their cars and ride their bicycles responsibly. Wear equipment to protect you and make you more visible to others, like a bike helmet, bright clothing (during the day), reflective gear, and a white front light and red rear light and reflectors on your bike (at night, or when visibility is poor). Plan your route if driving as a vehicle on the road; choose routes with less traffic and slower speeds. Your safest route may be away from traffic altogether, in a bike lane or on a bike path.

DUI Checkpoint Nets [2] Arrests

Camarillo, CA ' Camarillo Police Department Traffic Bureau conducted a DUI/Drivers License checkpoint on 3/2/18 on Arneill Road between the hours of 8:00 p.m. and 2:00 a.m. Checkpoints are placed in locations that have the greatest opportunity for achieving drunk and drugged driving deterrence and provide the greatest safety for officers and the public.

In recent years, California has seen a disturbing increase in drug-impaired driving crashes. Camarillo PD supports the new effort from the Office of Traffic Safety that aims to educate all drivers that 'DUI Doesn't Just Mean Booze.' If you take prescription drugs, particularly those with a driving or operating machinery warning on the label, you might be impaired enough to get a DUI. Marijuana can also be impairing, especially in combination with alcohol or other drugs, and can result in a DUI.

Studies of California drivers have shown that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol.

Drivers are encouraged to download the Designated Driver VIP, or 'DDVIP,' free mobile app for Android or iPhone. The DDVIP app helps find nearby bars and restaurants that feature free incentives for the

designated sober driver, from free non-alcoholic drinks to free appetizers and more. The feature-packed app even has social media tie-ins and even a tab for the non-DD to call Uber, Lyft or Curb.

Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, license suspension and other expenses that can exceed \$10,000 not to mention the embarrassment when friends and family find out.

Camarillo PD will be conducting another DUI/Drivers License Checkpoint on Friday, 4/27/18 in our ongoing commitment to lowering deaths and injuries upon our streets and highways.

The checkpoint was funded by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration, reminding everyone to 'Report Drunk Driver' Call 9-1-1'.

Credit card skimmer fraud is back! Be on alert! As our crime prevention officers like to say, 'Arm yourself with knowledge!'

Last year, Camarillo Police arrested four suspects responsible for placing credit card skimmers in

gas station pumps. This crew worked in conjunction with a larger crime ring that was responsible

for over \$90,000 in credit card fraud using the information from the skimmers. This arrest stopped hundreds of more crimes from happening.

Unfortunately, crime rings exist all over the country and even the world. Therefore, it is up to us to, 'Arm ourselves with knowledge' so we can be prepared at any time for any type of crime. The great news is'this is an easy learning lesson. So, what should you do'

- 1. Be Alert. When you gas up make sure the panel is closed and doesn't show signs of tampering. Many stations now put security seals over the cabinet panel. If the panel has been opened, the label will read 'void', which means the machine has been tampered with. (Photo credit: National Association of Convenience Stores (NACS) and Conexxus)
- 2. If you see something wrong, SAY SOMETHING. At the very least notify the gas station manager, or call the police department and we will have an officer come out and check the pump for you.
- 3. If you use a debit card at the pump, run it as credit instead of entering a PIN. If that is not an option, cover your hand when entering your PIN. Scammers often use pinhole cameras located above the key pad to record your numbers.
- 4. MONITOR your credit card and bank accounts regularly. In this day and age of online banking, this should be a daily task.
- 5. If you are really concerned about skimmers, pay inside the store.

The Camarillo Police Department would like the community to know that we have an anti 'skimmer' program in place and regularly check credit card devices throughout the city. If you notice something strange about a device you are using, contact Police Dispatch immediately at

Narrative:

In April of 2016, a 13-year-old Moorpark resident reported being the victim of continuous sexual abuse by a known suspect. Detectives followed up on the case and obtained evidence linking Jose Vaca, a Moorpark resident, to the crimes.

During the course of the investigation, Vaca is believed to have fled to Mexico.

On June 3, 2016, a detective presented the facts of the case to the Ventura County District Attorney's Office with a declaration for an arrest warrant. The warrant declaration was signed by a judge on June 3, 2016 for section 288.5(a) of the California Penal Code ' continuous sexual abuse of a minor.

Eighteen months later, on January 1, 2018, Jose Vaca was found in Ventura County and arrested for the outstanding \$100,000 warrant. He was booked at the Pre-Trial Detention Facility in Ventura at 7:18 p.m. Vaca posted a bond and was released from jail on January 2, 2018 at 8:21 p.m. Prior to his release, the United States Immigration and Customs Enforcement (ICE) sent an immigration hold for Vaca.

Sheriff's deputies did not notify ICE of Vaca's pending release, because the new law under Senate Bill 54 would not allow the notification under the circumstances. Although Vaca was arrested for a qualifying serious or violent offense, SB 54 requires that the arrestee has been arrested, booked and appeared before a judge prior to ICE being notified. In Vaca's case, he posted bail before he had appeared in court.

When he was released from jail, Vaca was ordered to appear in court on January 19, 2018.

However, he did not appear in court as required by law. A bench warrant was issued for Vaca's arrest for \$250,000. The victim has been notified of the circumstances in this case. She is safely living out of state with family, and there is no threat to her or her family at this time.

Vaca has not been located, and investigators believe he fled to Mexico. Detectives are actively trying to locate Vaca.

Due to a federal court ruling in 2014, jails in western states are prohibited from holding inmates beyond their scheduled release dates for ICE without a federal warrant. An ICE detainer or "hold" is not a federal warrant.

Narrative:

During recent special ceremonies, Camarillo Volunteers Pat McInerney, Mitch Kreeger and Thomas 'TJ' Eskridge were recognized and honored as their respective program's Member of the Year for 2017.

Pat McInerney joined the Camarillo Citizen Patrol in 2015. During that time Pat has volunteered over 2,000 hours during his career, including 900 in 2017 alone. Pat was born in the Bronx, and had a long career as a packing and shipping supply salesman, and began his law enforcement service as a volunteer at the Santa Paula Police Department, before moving to Camarillo. The Camarillo Citizen Patrol has evolved to become a city-sponsored volunteer program that includes patrol vehicles, uniforms, and equipment for members. Citizen Patrol units perform security house checks of city residents away on vacation, extra patrol of target areas, traffic control, special events and disasters. They may also be called upon to assist the Crime Prevention unit with other crime prevention programs and community services, such as Kid Print, McGruff and preventative talks.

The Camarillo Disaster Assistance Response Team (DART) awarded Mitch Kreeger their member of the Year for 2017. Mitch was recently elected as the DART Assistant Captain and has dedicated over 700 hours to the program. Mitch is self-employed at Kreeger Consulting Commercial and is a married father of one. The Disaster Assistance Response Team (D.A.R.T.) program is supervised by Camarillo Police personnel, who coordinate their training and exercises. Approximately 30 volunteers are participating in the program. D.A.R.T. members receive training in areas such as Communications, First Aid/CPR, Medical Emergencies, Cribbing and Shoring of Collapsed Structures and Traffic Crowd Control. Buzzed Driving Is Drunk Driving

Ventura County, CA' St. Patrick's Day is one of the most popular holidays in the United States. With a plethora of Irish immigrants'and many, many more St. Paddy's Day well-wishers, the holiday is heavily celebrated by most Americans with friendly pinches, bangers n' mash, and green beer galore. Sadly, all this merry-making can lead to dangerous driving conditions as party-goers head home.

In 2016 alone, 60 people were killed in drunk-driving crashes over the St. Paddy's Day holiday period (6 p.m. March 16 to 5:59 a.m. March 18) nationwide. The selfish act of drinking and driving can rip people from their friends and loved ones forever. For this reason, Ventura County Sheriff's Office is working to spread the message about the dangers of drunk driving. Even one drink can be one too many. If you're heading out for the Irish festivities, plan ahead and remember:

Camarillo, Moorpark, and Thousand Oaks Police Departments, which contract police services with the Ventura County Sheriff's Office, will deploy additional officers on special DUI Saturation Patrols specifically to stop and arrest drivers showing signs of alcohol or drug impairment during the hours of 8:00 PM and 3:00 AM.

Police, Sheriff and the CHP will be looking for signs of alcohol and/or drug impairment. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving, which now accounts for a growing number of impaired driving crashes.

Buzzed Driving Is Drunk Driving.

In recent years, California has seen an increase in drug-impaired driving crashes. The Ventura County Sheriff's Department supports the new effort from the Office of Traffic Safety that aims to educate all drivers that "DUI Doesn't Just Mean Booze." If you take prescription drugs, particularly those with a driving or operating machinery warning on the label, you might be impaired enough to get a DUI. Marijuana use can also be impairing, especially in combination with alcohol or other drugs, and can result in a DUI.

Remember: It's not just about you. There are other people on the roads who want to get where they are going safely. Don't let alcohol and or drug impairment cause you to be a risk to yourself and others on the road. Impaired driving is an act of selfishness. Before you put your keys in the ignition, remind yourself:

Ventura County Sheriff's Office recommends the following safe alternatives to drinking and driving:

- ' First: Always remember to plan ahead. If you plan to drink, plan for a sober driver to take you home. Is it your turn to be the designated driver' Take that role seriously'your friends are relying on you.
- ' There are many other ways to ensure a safe ride home besides relying on a friend. The OTS DDVIP app is now available for free download on iOS and Android devices. The app offers enhanced features, allowing users to search all participating bars and restaurants throughout California. Additionally, the app users can easily order asober ride from Uber, Lyft or Curb.
- ' Use your community's sober ride program.
- ' Have a friend who is about to drink and drive' Take the keys away and make arrangements to get them home safely.
- ' Always remember to report drunk drivers -call 911.

Narrative:

Three male juveniles conspired to commit a robbery from the Ojai Chevron. As a result, three victims were assaulted and multiple vehicle windows were smashed by the suspects during the commission of the crime.

On 3/15/18 at approximately 1900 hours, three male juveniles entered the Ojai Chevron located at 360 E. Ojai Ave. They had conspired together to commit a theft from Chevron prior to entering the business. Once inside they began stealing items. The clerk observed the theft and tried to stop the suspects from leaving. The suspects assaulted the clerk with a skateboard causing minor injury. A female patron tried to stop the assault and was also struck with a skateboard.

Sheriff's deputies arrived at the Chevron and arrested the 15 and 16 year old suspects. One of the suspects resisted arrest and a minor struggle ensued. The 17 year old suspect was able to flee the scene prior to the deputies' arrival.

Shortly after, Sheriff's deputies began receiving multiple calls of vandalism. They determined the 17 year old suspect who fled the scene had used his skateboard to break the windows of multiple vehicles in the area. A concerned citizen who witnessed the vandalism followed the suspect and directed deputies to his location. He was arrested and taken into custody without incident.

All three juvenile suspects were under the influence of alcohol and other controlled substances. The 17 year old suspect was transported via ambulance to Oiai Hospital due to his violent.

belligerent and unpredictable behavior. The other two suspects were also taken to Ojai Hospital for medical clearances. All three were booked at the Juvenile Justice Center for charges of conspiracy to commit a crime, robbery, and assault with a deadly weapon. The 17 year old suspect was also charged with felony vandalism.

Narrative:

Narrative:

On March 8, 2018, Deputies from the Thousand Oaks Police Station Directed Enforcement Unit along with Detectives from the Ventura County Narcotic's Task Force concluded a two-month investigation into a Los Angeles based heroin delivery service. As a result of the investigation, heroin delivery service customers (22), street level dealers (4), and heroin delivery service members (4), were arrested. Heroin, cash and guns were also seized. It is believed a majority of the heroin being supplied to Thousand Oaks and Moorpark was from this delivery service. Photos are available for viewing at: https://goo.gl/xbCr8e

Background:

One of the most prolific narcotics related threats to the residents of Ventura County is the heroin delivery service. Since February 1, 2012, there have been at least 149 opioid overdoses in the city of Thousand Oaks. In that same time period there have been at least 1,819 opioid overdoses in Ventura County. The vast majority of those overdoses have been non-fatal events. These overdoses have been from both heroin and prescription opioids. (Source: Ventura County EMS Agency).

The drug trafficking organizations that sell heroin are structured to sell their drugs to as many customers possible, often times providing door-to-door service. The heroin delivery service is typically made up of several components: (1) a cell head, who is the highest ranking member of the Drug Trafficking Organization within the United States, and who will typically recruit and vet workers and arrange for deliveries of drugs and drug proceeds between Mexico and the United States; (2) dispatchers, who are responsible for coordinating customers' incoming orders and dispatching drivers to deliver drugs to them; (3) stash house operators, who store and repackage drugs; (4) couriers, who are responsible for receiving incoming narcotics shipments and delivering proceeds to suppliers; (5) delivery drivers, who deliver narcotics to local customers; and, (6) the customer who either uses or resells a portion of their drugs to support their habit. Depending on the size and scope of the delivery service some of these roles may overlap or be further compartmentalized.

At the end of 2017, the Ventura County Narcotic's Task Force, in partnership with the United States Drug Enforcement Administration (DEA), arrested members of the "Manny's" heroin delivery service. Detectives from Ventura County anticipated newer and smaller services would quickly form and replace the void left from the conclusion of that investigation.

Investigation:

In January 2018, deputies from the Directed Enforcement Unit from the Thousand Oaks Police Department learned of a delivery service operating under the name of "Art's" or "Flaco's." The delivery service was purportedly delivering heroin multiple times a day to customers in the Ventura County cities of Camarillo, Thousand Oaks, Moorpark, and Simi Valley.

An investigation was immediately started which revealed Jose Zepeda, from Los Angeles, was the head of the delivery service. He also acted as full time dispatcher and part time delivery driver. Zepeda employed three delivery drivers, Ruben Correa, Eduardo Garcia, and Miguel Garcia. During the months of January, February, and the beginning of March 2018, while detectives were building the case, all three drivers were found to be delivering drugs to Ventura County. Law enforcement was able to observe some of the drug transactions and arrest Ventura County customers (See names of those arrested above under "Customers" and "Resellers"). Many of those arrested were using the drugs to feed their own addiction; some were reselling to support their habits. Several customers were stopped and arrested immediately after buying drugs from the delivery service. In other cases, search warrants were served at the customers' homes where other narcotics and firearms were discovered.

In one investigation, Alexander Wisotsky was arrested on February 26, 2018, at his home in the 500 block of West Gainsborough Road, in Thousand Oaks, with heroin possessed for sale, cash from drug sales, and 10 firearms. Additionally, Detectives from the Los Angeles Police Department arrested Eduardo Garcia on January 12, 2018, in the city of Simi Valley after they witnessed him dealing heroin. Garcia possessed multiple baggies of suspected heroin, enough for about 750 individual doses. After that arrest, Ruben Correa and Miguel Garcia handled most of the drug deliveries.

On March 8, 2018, search warrants were served at Zepeda, Correa, and Miguel Garcia's residences. Zepeda was arrested at his home in the 11500 block of Poema Place, Los Angeles. Over \$75,000 in suspected drug proceeds were found in his residence. Correa was arrested at his residence in the 7600 block of Owensmouth Ave, Los Angeles. About 6 ounces of heroin, or 1500 doses, were found at his house. Miguel Garcia was arrested at his home, in the 17100 block of Roscoe Boulevard, Los Angeles. A similar amount of heroin was found there.

All individuals arrested have pending court dates and are facing varying sentences based on their level of involvement in the investigation.

Detectives from the Ventura County Narcotics Task Force will continue to aggressively target, disrupt, and dismantle heroin delivery services that operate within Ventura County or supply residents of Ventura County.

The Thousand Oaks Directed Enforcement Unit consists of a Sergeant, two Senior Deputies and three Deputies. The Directed Enforcement Unit is tasked with aggressively identifying and arresting individuals involved in criminal activity in the City of Thousand Oaks.

Other units and officers throughout the Ventura County Sheriff's Office also assisted in this investigation including the Classification Unit at both the Pre-Trial Detention Facility and Todd Road Jail, as well as the Moorpark Patrol station.

The California National Guard ' Counterdrug Task Force provided substantial assistance in this case through investigative support and logistics.

On March 16, 2018, the Camarillo Police and Alcohol Beverage Control conducted an undercover operation to determine if local businesses would sell alcohol to a minor. Only one out

of twenty Camarillo alcohol sales locations sold to the minor.

Camarillo's Community Resource Unit with the assistance of agents from the California

Department of Alcohol Beverage Control conducted an alcohol sting, using underage minor decoys, in an attempt to purchase alcohol from various retail establishments in the City of Camarillo. The goal of this operation was to limit minors' access to alcohol and confirm retail establishments are abiding by the Business and Professions Code and rules set forth by the Department of Alcohol Beverage Control.

Underage decoys were used in an attempt to purchase alcohol from twenty-one locations throughout the City of Camarillo. Cashiers at twenty locations asked for identification and turned the decoys away without selling any alcoholic beverages. A cashier at Lantana Liquor sold to one of the underage decoys and failed to ask for identification. The cashier was cited for selling alcohol to a minor.

The Camarillo Police Department's Community Resource Unit will continue to conduct periodic sting operations in an effort to prevent minors' access to alcohol.

The police department would like to remind the public that selling alcohol to minors is illegal and that alcohol is a factor in many homicides and suicides; which along with car crashes are the leading causes of death in 15-20 year olds. The Ventura County Sheriff's Office wants to remind the public to report incidents of underage drinking and illegal purchasing of alcohol.

This week, Southern California is expecting a strong storm system that is forecast to bring significant rainfall to Ventura County. As the storm has moved closer to the region, the rainfall rates have been estimated to bring intensities that will exceed the thresholds for debris flows in the Thomas Fire burn area. The storm will arrive Tuesday afternoon with light rain steadily increasing through the overnight hours into Thursday morning. The highest rain intensities are expected between Wednesday afternoon and Thursday morning. The storm will gradually taper off Thursday.

Due to the high potential for mud and debris flows, the following mandatory evacuations will take effect on March 20, 2018 at 12:00 p.m.:

Matilija Canyon (North of Ojai Valley)

North Fork (North of Ojai Valley)

Vista Fire Burn Area (South end of Ojai Valley) Nye Road, West: Hwy 33, South: Nye/Hwy 33

La Conchita

Voluntary evacuations will also take effect in the following areas on March 20, 2018 at 12:00 p.m.:

Many areas in the county are susceptible to mudslides even without the impact the Thomas Fire has had on hillsides. The

Thomas Fire has stripped hundreds of square miles of mountains and

hillsides leaving no vegetation to hold the soil in place. According to geologists, who have surveyed the burn area, the incoming storm could bring enough rain to cause mud and debris flows in areas that were impacted by the Thomas Fire. Members of the community need to be aware that debris flows can occur suddenly and without warning.

In anticipation of this and other storms this season, the Ventura County Sheriff's Office and Ventura County Public Works have acquired thousands of sandbags to distribute to local residents and business owners so they can help protect their properties from mud and debris flows. The sandbags are being distributed through Ventura County fire stations in and around the Thomas Fire burn area, and they will have supplies on hand so residents can also fill sandbags in the event the pre-filled bags run out. Residents can get sandbags from local fire stations during normal business hours. When they are not involved in an emergency response, firefighters will be available to assist residents. Ventura City residents can learn where to receive sand bags by visiting www.cityofventura.ca.gov.

The Sheriff's Office of Emergency Services will open its Emergency Operations Center Tuesday morning, and has held planning meetings in advance of this rain event with our partner agencies, such as the Ventura County Fire Department, Ventura County Public Works, County Chief Executive Office, city leaders throughout the region, and the American Red Cross.

Residents need to be prepared to evacuate if necessary. We had great success with our notification systems during the Thomas Fire, but no system is perfect. Be aware, stay tuned-in and help your neighbors, friends and families stay up to date. If you are in an evacuation zone, a Red Cross shelter has been established at Ventura Community College 4667 Telegraph Road in Ventura. During this storm, residents can get the most up-to-date information about road closures and any areas impacted by the storm at the following website:

Driver's License/DUI Checkpoint Planned

Thousand Oaks, CA ' The Thousand Oaks Police Department Traffic Unit will be conducting a Driver's License/DUI Checkpoint on March 24, 2018 at an undisclosed location(s) within the city limits.

The deterrent effect of High Visibility Enforcement using both DUI checkpoints and DUI Saturation Patrols has proven to lower the number of persons killed and injured in alcohol or drug impaired crashes. Research shows that crashes involving an impaired driver can be reduced by up to 20 percent when well-publicized proactive DUI operations are conducted routinely.

DUI Checkpoints like this one are placed in locations based on collision statistics and frequency of DUI arrests, affording the greatest opportunity for achieving drunk and drugged driving deterrence. Locations are chosen with safety considerations for the officers and the public.

In California, alcohol involved collisions led to 1,155 deaths and nearly 24,000 serious injuries in 2014 because someone failed to designate a sober driver. Locally, over the course of the past three years, DUI collisions have claimed 6 lives and resulted in 85 injury crashes harming 112 of our friends and neighbors.

Officers will be looking for signs of alcohol and/or drug impairment, with officers checking drivers for proper licensing, delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving, which now accounts for a growing number of impaired driving crashes.

Studies of California drivers have shown that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol. Everyone should be mindful that if you're taking medication 'whether prescription or over-the-counter 'drinking even small amounts of alcohol can greatly intensify the impairment affects.

The California Office of Traffic Safety DDVIP (Designated Driver VIP) mobile app is now available for free to download on iOS and Android devices. Launched last year, the new DDVIP app offers enhanced features, allowing users to "Map a Spot" with their current location to find DDVIP partnering establishments in their area or a "List of Spots" to search all participating bars and restaurants throughout California. Users will be offered free incentives at each bar to celebrate their life saving role. They can stay up-to-date with the latest from DDVIP and see what other users are saying via its social tab. Also through the app, for those who want to imbibe but also make it a point to plan ahead, users can easily order a sober ride from Uber, Lyft or Curb- all from one screen. Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI

classes, license suspensions and other expenses that can exceed \$10,000 not to mention the embarrassment when friends and family find out.

Narrative:

Detectives have been conducting an extensive follow-up investigation into all aspects of the shooting that occurred last Saturday at the Oaks Mall. There was one previous reported case of domestic violence involving Kevin Crane and Parisa Siddigi.

In September 2014, deputies were called to a residence in Thousand Oaks to investigate a domestic disturbance involving the couple. Deputies concluded that Crane had battered Siddiqi during a dispute, and she suffered minor injuries as a result. Crane was arrested for felony domestic battery and booked into jail. During that investigation, deputies seized a Glock .40-caliber handgun and booked it in the sheriff's property room for safekeeping. The handgun belonged to Kevin Crane, but it was not used during the domestic violence incident.

The Ventura County District Attorney's Office filed one count of misdemeanor domestic battery against Crane. The DA's Office also filed a petition to confiscate Crane's handgun. Crane did not contest the petition, and in November 2014, a judge ordered that the handgun be confiscated. At that time, the gun was still being stored in the sheriff's property room.

In January of 2015, the District Attorney's Office dismissed the domestic violence case against Crane, because the victim, Parisa Siddiqi, would not cooperate with investigators and could not be located for service of a subpoena to appear in court. On an unknown date, Crane submitted a Law Enforcement Gun Release application to the California Department of Justice for the Glock handgun. On March 3, 2015, Crane received a letter from the DOJ that he was eligible to possess the firearm. Crane went to the East County Sheriff's Station and the handgun was returned to him in March of 2015. At that time, Crane was no longer being prosecuted for

domestic violence. Crane was eligible to lawfully purchase a gun at any time after receiving the March 3, 2015 letter from DOJ declaring he was eligible to possess a firearm.

The property room staff was unaware of the court's order to confiscate the firearm at the time it was returned to Crane. Detectives learned the DA's Office received the order after it was issued in November of 2014. A District Attorney's Office clerk sent a copy of the court order via inter-office mail to the sheriff's office. There is a record of the court order being received by the sheriff's office in October of 2015. Inter-office mail has no system in place to track the sending of documents. Investigators are working to determine why there was a lapse in time between the order being issued and the document being received. The Ventura County Sheriff's Office and the District Attorney's Office are reviewing the process and are taking steps to ensure this never happens again. The handgun released to Crane was the only gun

registered to him. It was the same handgun used to murder Siddiqi last Saturday.

Crane remains in critical condition at a local hospital with a self-inflicted gunshot wound to the head. The decision to arrest Crane will depend on whether he recovers from his injuries.

On March 20, 2018 at about 10:53 am, a suspected burglar jumped a fence to enter a locked backyard of a residence on Parkway Drive in the City of Camarillo. The suspect walked around the victim's backyard and tried to open a locked door, but was not able gain entry into the home. The suspect left the yard without completing his crime.

The homeowner had a security system that included several cameras. Detectives from the Camarillo Police department reviewed the evidence and immediately identified the suspect from the video. Detectives believe that the homeowner prevented the burglary by simply locking the doors to their house while they were gone.

On March 21, 2018, detectives located the suspect, who was determined to be a juvenile, and arrested him without incident. The suspect was later booked into the Ventura County Juvenile Justice Facility for attempted burglary.

The Camarillo Police Department would like to remind homeowners that most daytime burglars are looking for a quick entrance into a home and quick escape. Most do not want to confront residents. These suspects will often knock on the front doors to determine if anyone is home prior to breaking in. Locking your doors and windows to prevent entry is essential to prevent these crimes. If an unknown person knocks on the door, homeowners are advised to acknowledge that you are home, but do not open the door to strangers. Homeowners should not let strangers into their home to use the phone or restroom. Suspicious subjects or incidents should be immediately reported to the police department.

There are commercial video and doorbell systems available that allow homeowners to monitor cameras and communicate with visitors remotely from inside or while away from your home. In January of 2018, deputies from the Thousand Oaks Police Department responded to the 100 block of West Avenida De Los Arboles for a stolen vehicle report. Nguyen took the money from the victim that was intended to pay for the vehicles and apartment but never forwarded the money to the financial institutions. Detectives determined Nguyen stole approximately \$200,000.00 from the victim.

On March 22, 2018, investigators served a search warrant at Nguyen's residence located in the 1500 block of Synergy in the City of Irvine. As a result of the search, Detectives located and seized numerous financial documents and \$3,800.00 in United States currency. Nguyen was arrested for violating Penal Code section 532(a) / theft by false pretenses. Nguyen was transported back to Ventura County and booked into jail. He remains in custody on \$100,000

March 2018 DUI / Driver's License Checkpoint

On March 24, 2018 the Thousand Oaks Police Department Traffic Bureau conducted a DUI / Driver's License Checkpoint at two locations in the City of Thousand Oaks. Vehicles were screened as they passed through the checkpoint locations. Two arrests were made for DUI and one arrest was made for out of county warrants. Several citations were issued for unlicensed driver and/or for having a suspended/revoked driver's license.

The first Checkpoint location was west bound Borchard Road, east of Wendy Drive from 8:25 pm to 11:00 pm. The second location was east bound Avenida De Los Arboles, east of Calle Haya from 11:30 pm to 2:30 am. Checkpoints are placed in locations that have the greatest opportunity for achieving drunk and drugged driving deterrence and provide the greatest safety for officers and the public.

DUI / Driver's License checkpoints have been shown to lower DUI deaths and related injuries. A major component of these checkpoints are the deterrent effects it has on those who might drive alcohol and/or drug impaired, bringing about more awareness and encouraging alcohol or drugged impaired drivers to use sober designated drivers.

According to the National Highway Traffic Safety Administration (NHTSA), checkpoints have provided the most effective documented results of any of the DUI enforcement strategies, while yielding considerable cost savings of \$6.00 for every \$1.00 spent. Ninety percent of California drivers approve of checkpoints.

During the listed Checkpoint Operation the following occurred:

- ' 562 vehicles entered the Checkpoint
- ' 562 vehicles were screened in the Checkpoint
- 'Two DUI alcohol impaired arrests were made
- ' No DUI drug impaired arrests were made
- ' Four drivers were cited/arrested for operating a vehicle while unlicensed or for having a suspended/revoked driver's license
- ' A total of nine citations were issued
- ' One arrest was made for out of county warrants.

Law Enforcement emphasizes the preventable nature of DUI, reminding everyone that all it takes is a little preplanning. Designate a sober driver, call a friend or family member for a ride or call a cab. Whatever you do, don't drink and drive or drive while drug impaired. Through the California Office of Traffic Safety (OTS), the DDVIP (Designated Driver VIP) mobile app is now available for free to download on iOS and Android devices. Launched last year, the new DDVIP app offers enhanced features, allowing users to "Map a Spot" with their current location to find DDVIP partnering establishments in their area or a "List of Spots" to search all participating bars and restaurants throughout California. Users will be offered free incentives at each bar to celebrate their life saving role. They can stay up-to-date with the latest from DDVIP and see what other users are saying via its social tab. Also through the app, for those who want to imbibe but also make it a point to plan ahead, users can easily order a sober ride from Uber, Lyft or Curb-all from one screen. Driver's caught driving under the influence can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, and other expenses that can exceed \$10,000. That does not include embarrassment when family and friends find out.

The Thousand Oaks Police Department will be conducting another DUI/Driver's License checkpoint on April 28, 2018 (Saturday), in our ongoing commitment to lowering deaths and related injuries on our streets and highways.

Sheriff's Narcotics Unit and Camarillo Police Department Special Enforcement Detail. Detectives from these investigative units continued with the investigation and search for the two females. After approximately 24 hours of ongoing investigation and searching, the 16-year-old juvenile victim was located in the Sacramento area, the 20-year-old female was found with the suspect, James Powell, preparing to check into a hotel in Manhattan Beach.

Powell was arrested and transported back to Ventura County where he was booked into the Ventura County Jail on human trafficking charges with a bail set at \$510,000.00. The District Attorney's Office filed 2 counts of human trafficking 236.1(c)(2) PC and 2 counts of human trafficking 236.1(a) PC on Powell. A Preliminary Hearing for Powell is scheduled for April 6

th

2018 in Ventura Superior Court.

The Ventura County Sheriff's Office has a dedicated human trafficking investigator assigned to the Special Crimes Unit. This investigative unit is responsible for investigating various criminal organizations operating throughout Ventura County. The Sheriff's Office investigates human trafficking cases with a victim centered approach as these victims are often in need of additional resources because they lack a support base. The Sheriff's Office teams up with public and private organizations to bridge the gap in resources for these victims. In this particular case, Interface and the Federal Bureau of Investigations victim services unit provided assistance to the

victims in this case.

On 03/29/2018, Three suspects were arrested on firearm and assault charges committed in the Ojai Valley. This incident was stemming from a multi-day dispute between the victims and suspects.

On March 22

th Sheriff's Deputies and Detectives responded to Nordhoff High School reference an altercation that had just occurred on school property. After interviewing the victims and multiple witnesses, Detectives were able to determine (S) Anzel Griffith had entered onto school property and committed a battery against the 15 year old victim regarding stolen property. The 15 year old victim admitted to stealing Anzel's two small motorcycles with another 17 year old victim on, 03/17/2018. Based on multiple witnesses, the 15 year old victim, and suspect statements, at no time were any gun(s) brought onto the campus, or seen, at Nordhoff High School. th incident at Nordhoff High School, revealed details of an incident that had occurred on 3/22/2018: nd Anzel and his father, (S) Stuart Griffith, had participated in a vehicle chase with the two juvenile victims through the Ojai Valley. The vehicle chase ended at the entrance of the Rancho Matilija Gated Community where Anzel brandished a 9mm handgun at the victims. Stuart and Anzel forcibly removed the victims from the vehicle, knocking them to the ground and

delivering multiple kicks to the head and torso areas of both victims.

Due to the incidents on 3/22/2018 and 03/29/2018, Anzel contacted Stuart after leaving the assault at Nordhoff High School. In fear of the police coming to their residence with a search warrant, Stuart instructed Anzel and his wife, (S) Angelica, to remove all firearms from their residence and transport them to a separate location prior to police arrival. Detectives from the Sheriff's Gang Unit, who were already surveilling the suspect's home, observed Anzel and Angelica place multiple firearms in their vehicle and leave the area. Sheriff's Deputies and Detectives from the Gang Unit conducted a traffic stop on the vehicle and all parties were arrested.

This incident resulted in the suspects being arrested for the following charges:

PC 245(a)(4) - Assault by means to produce great bodily injury

PC 422(a) ' Criminal Threats

PC 417 (2) 'Brandishing a Firearm

PC 32 ' Accessory after the fact

Additional charges are pending reference a modified non-California complaint AR-15 that was found during the arrest.

An investigation into the original motorcycle thefts, burglary and conspiracy charges are now underway.

At no time did either party contact police to report the theft of the motorcycles on March 17

Throughout the incident at Nordhoff High School, Ojai Police Chief, James Fryhoff, continued to update Ojai Unified School District Superintendent, Andrew Cantwell. Superintendent Andrew Cantwell said: "We are grateful to our partnership with the Ventura County Sheriff's Office and for their help in bringing this incident to a safe conclusion. Students' safety is our first priority and we have worked diligently with local police and our school community to make our campuses as safe as we can. We must, as a community of educators, students, parents and police, teach our children that there are non-violent ways to resolve their differences."

All suspects were transported and booked into the Pre-Trial Detention Center in Ventura, CA.

Small Plane Crashes Near Santa Paual, Killing Two

Narrative:

A small airplane with two men on board crashed near Santa Paula Airport, killing both occupants. The plane came down on a ranch property, narrowly missing several homes in the area. The plane clipped a storage container and a wall, before breaking apart among some trees, igniting a small fire.

The pilot and passenger were pronounced dead at the scene after the fire was quickly extinguished. Nobody on the ground was injured. The cause of the crash is unknown, and the origin and destination of the flight have not been determined. Investigators from the National Transportation Safety Board will arrive at the crash site Sunday morning to examine the scene. The identities of the two men have not yet been released, pending notification of next of kin.
