Narrative:

On September 28, 2018, Detectives from the Ventura County Sheriff's Office East County Street Narcotics Team concluded a narcotics sales investigation into Tyler Myers of Newbury Park, who was involved in the sales of cocaine to residents of Ventura County.

On September 28, 2018, City of Thousand Oaks patrol deputies assisted and conducted a traffic stop of Myers in the City of Camarillo. Detectives searched his vehicle pursuant to a signed search warrant. During the search, detectives found over a half ounce of cocaine packaged for sale, over two pounds of marijuana, and a loaded unregistered firearm. Myers was arrested and transported to the East County Jail.

Following Myers' arrest, Narcotics Detectives and Detectives from the Camarillo Special Enforcement Detail executed a search warrant at Myers' residence located in the 100 block of Cathy Drive in Newbury Park. Detectives located steroids, a small quantity of cocaine, US currency deemed to be proceeds from narcotics sales, and paraphernalia indicative of illegal narcotic sales.

Myers was booked into the East County jail on various narcotics and firearms charges. Myers' bail was set at \$50,000.00. Myers was released on bail and is scheduled to attend court on October 12, 2018.

Narrative:

Since November 2017, detectives with the Camarillo Special Enforcement Detail (SED) have been conducting an investigation into the residence of Leona Comer and her son, Jason regarding a high number of illegal drug arrests from the location. On 09/23/2018, both Leona and Jason were arrested for violating HS 11366- Owning/Maintaining a Residence Where Illegal Substances are Sold, Furnished, or Used.

In November 2017, detectives with the Camarillo Police Special Enforcement Detail (SED) noticed an increase in illegal drug arrests occurring at a residence in the 5500 block of Butterfield Street in Camarillo. In addition to the arrests, detectives were aware that numerous probation searches were occurring and knew several known drug users were frequently located at the residence. The homeowner was identified as Leona Comer. Leona lived at the residence with her son, Jason Comer. Jason is on Ventura County probation with search terms for controlled substances.

During the course of the investigation, detectives determined that since January 2018 the Camarillo Police Department had been called to the residence on numerous occasions, over 25 probation searches and more than 25 arrests had been made. There were a total of 16 different people either visiting or staying at the residence that were involved with these arrests and probation searches. During a one week period in early September 2018, ten arrests were made at the location for a variety of drug related offenses, including PC 148(a) (1)- Resist, Obstruct, or Delay a Peace Officer, HS 11550(a)- Under the Influence of a Controlled Substance, HS 11377(a)- Possession of a Controlled Substance, HS 11350(a)- Possession of a Controlled Substance and HS 11364(a)- Possession of an Ingestion Device. Leona and Jason were present during the majority of the arrests and probation searches. Also during this one week period, detectives had to force entry into the residence to conduct a probation search because the occupants refused to open the door for deputies. After forcing entry into the residence, four

people were found hiding inside and were arrested for various drug related charges. Leona knowingly obstructed deputies' lawful investigation during this probation search by refusing to open the door to law enforcement and she was issued a misdemeanor citation for PC 148(a)(1).

At the conclusion of this investigation, detectives determined the Comer residence was being maintained for the purpose of being a place where illegal drugs are being furnished, and/or consumed. On 09/23/18, Camarillo SED detectives went to the residence and arrested Jason Comer and Leona Comer for HS 11366. Both suspects were booked at the Ventura County Pre-Trial Detention Facility, with a pending court date.

Property crimes, including mail theft, identity theft, and residential and vehicle burglaries, are often committed by drug users. By giving drug users a haven to use drugs within our community, these homeowners invite criminals into their neighborhoods, causing their neighbors to be victimized. It should be known that homeowners can be found criminally responsible for drug users consuming drugs in their residence.

The Camarillo Police Department's Special Enforcement Detail is a five person plain clothes detail that conducts a variety of investigations of crimes within the city of Camarillo. The goal of Camarillo SED is to reduce property crime and violent crime through investigations and directed enforcement.

Narrative:

On October 3, 2018, Detectives from the Ventura County Sheriff's Office East County Street Narcotics Team and the Thousand Oaks Directed Enforcement Unit concluded a narcotics sales investigation into Dana Douglas of Thousand Oaks, who was involved in the sales of methamphetamine to residents of Ventura County.

On October 3, 2018, deputies with the Directed Enforcement Unit conducted a traffic stop on Douglas in Thousand Oaks. Detectives searched his vehicle pursuant to a signed search warrant. During the search, detectives found over an ounce of methamphetamine packaged for sale. Douglas was arrested and transported to the East County Jail.

Following Douglas' arrest, Narcotics Detectives executed a search warrant at a residence associated with Douglas located in the 1900 block of Gardenstone Court in Thousand Oaks. Detectives located a small quantity of methamphetamine and paraphernalia indicative of illegal narcotic sales.

During the course of the search, detectives determined an occupant of the residence John Kuhl was cultivating marijuana in the backyard of the residence. The investigation revealed the cultivation was not within legal guidelines of Proposition 64, which legalized marijuana after being voted upon by California voters in 2016. Kuhl did not have any permits or licenses issued by the County of Ventura or the City of Thousand Oaks required to cultivate more than the allowed 6 plants of marijuana. Detectives seized numerous marijuana plants and over ten pounds of processed marijuana.

Douglas was booked into the East County jail for possessing controlled substances for sale and his bail was set at \$130,000.00. Kuhl was arrested for misdemeanor possession of a controlled

substance.

Narrative:

The law enforcement agencies listed above concluded a year-long investigation into the distribution of controlled substances throughout Ventura and Los Angeles Counties. The investigation resulted in dismantling a Los Angeles based drug trafficking organization and the arrests of thirteen suspects for a variety of narcotics sales and weapons possession.

During the month September 2017, detectives from the Ventura County Combined Agency Task

Force began investigating a Los Angeles County subject who was suspected of dealing bulk-quantities of narcotics to the residents of Ventura County. During this investigation, detectives learned that the source of narcotics was Omar Rangel (29 years / San Fernando Valley resident). Rangel was the leader of a Los Angeles based drug trafficking organization, which involved numerous persons. This drug trafficking organization was found to be moving substantial quantities of narcotics originating from a drug cartel in Sinaloa, Mexico and then distributing the drugs to bulk-quantity traffickers in Los Angeles and Ventura Counties.

Throughout this investigation, detectives served numerous narcotics-related search warrants, which resulted in the seizure of large amounts of narcotics, indicia of drug sales, weapons, and several arrests.

During the course of the investigation, detectives seized a total of 161 pounds of methamphetamine, 121 pounds of cocaine, 13.2 pounds of heroin, 6.6 pounds of fentanyl, 600 fentanyl pills, more than \$353,000 in drug-sales proceeds, and 12 firearms.

The combined street value of the seized drugs was more than \$10,800,000.

All of the above-listed subjects were booked during the course of this investigation, or their arrests are imminent, pending arrest warrants.

The Ventura County Combined Task Force is made up of members from local, state and federal law enforcement agencies who work collaboratively to identify, disrupt, dismantle, and prosecute major narcotics trafficking organizations.

' If you are DD, bars and restaurants statewide have created non-alcoholic specialty drinks ("DDrinks") for sober drivers: http://bit.ly/OTSDDrinks. ' If you happen to see a drunk driver on the road, call 911. Offer a description of the vehicle, location and direction of travel. ' See your friend or other patron impaired trying to get behind the wheel' Take the keys or help them make other arrangements to get where they are going safely. Drivers caught driving impaired and charged with DUI can expect the impact of a DUI arrest to be approximately \$13,500. On 10/12/18, the Ventura County Sheriff's Gang Unit concluded a two month multi-agency investigation into a City of Ventura public nuisance within the 200 Block of West Harrison Avenue.
